In this regard, all ROS are directed to:

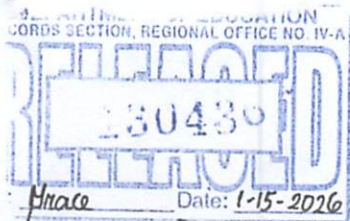
- identify one Schools Division Office (SDO) per region that will serve as the host of the activity;

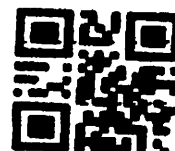
