The Sorsogon State University (SorSU) will host the 2nd Southeast Asian Multidisciplinary Research Expo and Extension Conference (SEAMREEC 2025), with the theme, Create. Capacitate. Collaborate. Connect: Driving Global Sustainability through Multidisciplinary Research and Extension, on June 24–27, 2025.

The SEAMREEC 2025 supports the internationalization policy framework for higher education institutions (HEIs) while promoting Sorsogon as an emerging eco-tourism destination in the Philippines. It aims to

1. provide a platform for teachers, scholars, and administrators to engage in academic exchange of scientific knowledge, innovations, and practical approaches;
2. facilitate the knowledge-sharing and best practices among researchers across various disciplines; and
