Such transfer of rights includes but are not limited to the right to use, produce or reproduce, and prepare derivative works of the designs for whatever purpose and whichever form as may be deemed fit by the GSIS without further compensation to the artists or their heirs.

I am also giving my consent to GSIS Museum staff to provide information as to my mobile number and or email address (as needed only) in case that there are interested art collectors/buyers of my art competition entry.

By providing my personal and sensitive personal information in this form, I confirm my understanding of the Privacy Policy of GSIS in compliance with the Republic Act (R.A.) No. 10173, otherwise known as the Data Privacy Act (DPA) of 2012 and its Implementing Rules and Regulations (IRR). Also, this is to give my consent on the manner of collection, use, access, disclosure, storage, and processing of my personal and sensitive

personal data by the GSIS. Further, any related personal information such as photos and videos collected during this event may be used by the GSIS for promotion and collaterals, without the need to acquire my permission and compensation of its use.

THE 2025 GSIS NATIONAL ART COMPETITION

The Government Service Insurance System (GSIS) is inviting all Filipino artists (award winning artists, senior artists, student artists, art professors, hobbyists, members of art groups) to join the 2025 GSIS National Art Competition, which is now on its 20th year.

Starting **February 10, 2025**, official entry forms can be obtained from the GSIS website (<u>www.gsis.gov.ph</u>). To ensure eligibility, all potential participants should thoroughly review the competition's guidelines, rules, and regulations to avoid disgualification.

CATEGORIES

1. There will be only two (2) categories this year :

- 1.1 Representational Category (Representational) in horizontal / landscape orientation;
- 1.2 Non-representational Category (Abstract) purely non-representational, non-recognizable figures and objects in horizontal / landscape orientation;

ELIGIBILITY AND ENTRY REQUIREMENTS

- The competition is open to all Filipino artists who are at least 18 years old as of April 26, 2025. Officers of the Art Association of the Philippines (AAP) and individual artists officially assisting the 2025 GSIS National Art Competition are not eligible to participate in the competition.
- Participants can ONLY submit one (1) entry in a category of their choice. Artists can no longer join in both categories. No participation fee is required.
- 4. THEME FOR REPRESENTATIONAL "OPEN"

INFORMATION	Textured paint, such as Versatex or Gesso, is acceptable primer for the entries.
	Entries should be ready for exhibition, framed and with proper hanging system using nylon cord (tansi) only.

- 6. Entries should be dated not earlier than 2025; be the original work of participating artists; and not have been exhibited before, revised, and awarded a prize in previous competitions.
- 7. Entries **SHOULD BE SIGNED** by the artist; the signature should be covered with masking tape prior to submission to conceal the artists' identity. They should also be properly labeled using a card tag or card caption to be placed at the back of the artworks. The card tag should contain the following information: Artist (name, address, and contact numbers), Title of the artwork, medium, size, year and price, if the artwork is for sale. Writing the information directly on the canvas is not allowed.

8. <u>PHYSICAL SUBMISSION OF ACTUAL ARTWORK</u>: All participating artists should be responsible for bringing and transporting their entries to GSIS, Pasay City. Submitted artworks with wet paint will not be accepted. Entries submitted through courier (Lalamove, GRAB, etc.), is strictly prohibited, except those entries coming from provinces <u>OUTSIDE</u> the National Capital Region (NCR), Cavite, Laguna, Batangas, Rizal Province, Quezon Province, Bulacan, Tarlac, and Pampanga.



9. Entries coming from the provinces may send their artworks through mail forwarders. Artists from the same province are encouraged to send their entries by group to save on freight/shipping cost. Shipping cost during submission and retrieval shall be shouldered by the participating artists. However, the GSIS shall not be responsible for any damage the artwork may sustain during shipment.

Artists or groups from provinces OUTSIDE the National Capital Region (NCR), Cavite, Laguna, Batangas, Rizal Province, Quezon Province, Bulacan, Tarlac, and Pampanga using official couriers only (such as LBC, JRS, and other registered couriers) should also advise their mail forwarders of choice that the GSIS will only accept their entries on April 26, 2025 from 8:00 AM until 4:00 PM only. Entries submitted beyond the stated period is automatically disgualified. Artists should inform their chosen courier that all entries should be delivered INSIDE the GSIS Gymnasium. GSIS Museum staff will not pick up packages from couriers outside the venue.

10. Participating artists SHOULD SUBMIT the following along with every entry:

10.1 Completely filled-out, signed and <u>notarized official entry form</u> with ONE (1) 2" x 2" colored ID picture of the artist. (Forms can be downloaded from the GSIS website)

ENTRY FORM should be notarized certifying originality of entry and subscription to the rules and regulations of the competition.

 - 10.3 **5" x 7" colored photo of the artwork** (computer printed colored photo is allowed) with the following information written at the back: artist's name, address and contact number, title of the artwork, medium, size, year, and price (if the artwork is for sale).

- 10.4 Completely filled-out and signed **retrieval form**. (Forms can be downloaded from the GSIS website and are available at the GSIS Gym during submission)
- 11. All possible care shall be taken by the GSIS to protect the entries received in the competition. However, the GSIS assumes no responsibility for any loss or damage to the entry before, during and after the competition. Artists shall not hold the GSIS and any of its officers and staff liable for the loss or damage to the works while in exhibit or storage.
- 12. Entries from nearby places, i.e. National Capital Region (NCR), Cavite, Laguna, Batangas, Rizal Province, Quezon Province, Bulacan, Tarlac, and Pampanga should be physically submitted to the GSIS Head Office, Financial Center, Reclamation Area, Pasay City (CCP Complex – JW Diokno Blvd.) on April 26, 2025 (Saturday) FROM 8:00 AM UNTIL 5:00 PM only.
- Entries submitted <u>BEFORE or AFTER</u> the stated date and time in item No. 9 and 12 will not be accepted and shall be labeled as disqualified.
- 14. Entries with incomplete documentation or do not comply with the requirements shall be automatically disqualified.

JUDGING

- 15. The GSIS shall have the sole prerogative to select the Board of Judges.
- 16. The decision of the Board of Judges **SHALL BE FINAL.** Judges may decide not to award prizes to any entry that does not meet certain artistic and competition requirements.
- 17. The GSIS has the right to check and verify randomly selected entries. Issues on copyright infringement will be seriously considered and deliberated for the declared finalists. Complaints should be submitted to the GSIS within 14 calendar days from the date of announcement of finalists. Likewise, the GSIS may send GSIS Museum staff to conduct an on-the-spot ocular visit in the artist's studio or home. The GSIS has the right to automatically disqualify the artist if the entry does not meet the prescribed guidelines.
- All major prize winners (1st, 2nd, and 3rd), <u>INCLUDING</u> the honorable mentions (for representational AND non-representational), shall automatically become properties of the GSIS and shall form part of the GSIS Art Collection.

20. Finalists will be initially announced online on May 9, 2025 (Friday) and their names shall be uploaded in the official GSIS Facebook page. After 14 calendar days, without receiving any complaints or protests on the originality/authenticity of the artworks, the GSIS shall officially announce the grand prize winners on June 6, 2025 (Friday).

OTHER PROVISIONS

- 21. The ownership of all prize-winning works and honorable mentions including their copyright/economic rights, as provided under the law, shall be transferred by the artists to the GSIS and the moral rights thereof shall be waived in favor of the GSIS. Such transfers of rights include but are not limited to the right to use, produce or reproduce, and prepare derivative works of the designs for whatever purpose and whichever form as may be deemed fit by the GSIS without further compensation to the artists or their heirs.
- 22. The GSIS reserves the right to use the names and photos of the artists and their entries for free in any broadcast, print, or digital media and to exhibit the same as may be deemed fit. It further reserves the right to **decide which entries will be displayed during the competition exhibit** as well as those to be **included in the Catalogue of Entries**.
- 23. The artist can sell his/her work and is responsible in dealing with prospective buyer/s. Entries on display should not be taken out from the GSIS Museum within the duration of the exhibit. Thus, artist should inform the buyer that the artwork can only be released beginning **September 20**, **2025**; otherwise, such will not be included in the catalogue.
- 24. Retrieval of non-winning entries shall strictly be done from <u>September 27 until</u> <u>November 8, 2025 ONLY</u>. Retrieval through courier (Lalamove, GRAB, etc.), except those entries coming from Visayas and Mindanao areas, is strictly prohibited. Shipping/transport expenses shall be shouldered by the artist and not by the GSIS. Arrangement for the said retrieval shall be made by the artist or his/her designated representative.

In claiming entries, the artist SHOULD submit/bring the following requirements:

24.1 Printed retrieval form; and



24.2 One (1) valid ID.

Those who will send representatives SHOULD submit the following documents:

24.3 PRINTED Authorization letter signed by the artist indicating name of the representative (*Authorization letter sent through messenger is not acceptable*);

24.4 Photocopy of artist's ID with signature; and

24.5 Photocopy of the representative's ID.

- 25. The ownership, including the copyright or economic rights, of all non-winning artworks that were not claimed beyond the period prescribed above is transferred by their artists to the GSIS and moral rights thereof shall be waived in favor of the GSIS.
- 26. All unclaimed non-winning artworks shall be disposed of in any manner deemed appropriate by the GSIS, including the donation thereof to GSIS offices, public schools, and other government institutions, without need of prior notice to the artists and without further compensation to them or their heirs. The remaining artworks shall be endorsed to the winning service provider of the competition who shall facilitate the auction thereof, and the resulting proceeds shall be used to support artists in need and fund related activities
- 27. All information/data provided by the artists shall be considered confidential in compliance with all the provisions of Republic Act No. 10173, known as the "Data Privacy Act of 2012" and its Implementing Rules and Regulations.
