- 6. A registration fee of SIX THOUSAND PESOS (P6,000.00) shall be charged to each participant to cover the expenses for convention hall, meals, assembly kit, honoraria of resource persons and facilitators and other incidental expenses chargeable from MOOE, SEF, local funds, and any other sources subject to the usual accounting and auditing rules and regulations.
- 7. Members of the Technical Working Group (TWG) such as school heads, head teachers and master teachers are considered participants and are required to pay the registration fee. They are authorized to travel two days prior to the start of the activity for the necessary preparations.
