Participants will take their time to report the results of their investigation on the given breach simulation, both technical and compliance reports that is why we encourage you to form or create a Breach Response team (minimum number or three (3) or more participants) to be headed by the Data Protection Officer (DPO) to attend and participate on the "Breach Response Team Report.
