Greetings from the Procurement Service - Department of Budget and Management (PS-DBM)!

PS-DBM is the agency tasked with the centralized procurement of common-use supplies and equipment (CSE) for the government. Furthermore, Section 40 of Republic Act No. 12009 or the New Government Procurement Act (NGPA) mandates that all national government agencies, government-owned and controlled corporations, government financial institutions, state universities and colleges, and local government units shall procure their CSE requirements from the PS-DBM.

The CLE is part of PS-DBM's ongoing digital transformation and capacity-building initiatives that aims to help government agencies enhance their efficiency and adaptability in utilizing the modernized Philippine Government Electronic Procurement System (mPhilGEPS) e-commerce platforms, including the eMarketplace and the Virtual Store.
