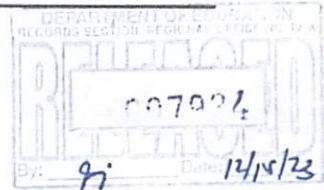

Both school personnel and learners should also be guided by **DepEd Order No. 105, s. 2010** titled **Reiterating the Constitutional Right of DepEd Personnel and Students to Free Exercise of Religion** which emphasizes the following:

"No law shall be made respecting an establishment of religion, or prohibiting the free exercise thereof. The free exercise and enjoyment of religious profession and worship, without discrimination or preference, shall forever be allowed. No religious test shall be required for the exercise of civil or political rights."

Likewise, attention is invited to **DepEd Order No. 49, s. 2009**, titled **"Reiterating The Revised Rules and Regulations on the Teaching of Religion in Public Elementary and Secondary Schools"**.


