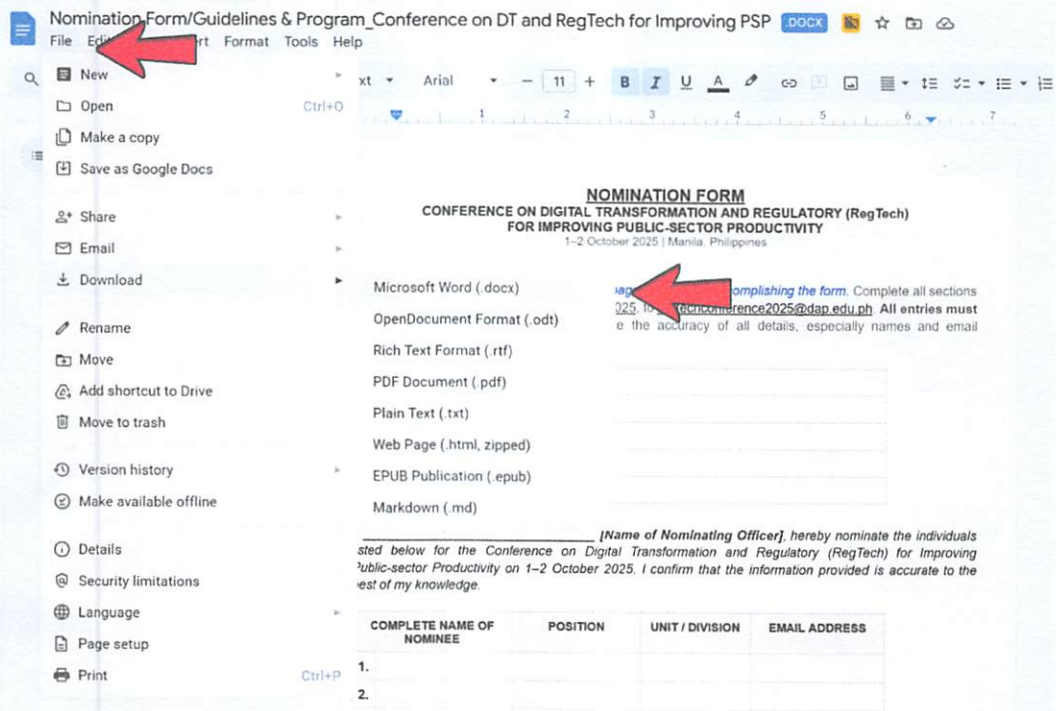

## NOMINATION GUIDELINES

### **Submission of Nominations**

1. Download a .docx format of this document by clicking on "File > Download > Microsoft Word (.docx)" at the top left side of the window.



2. Accomplish the form by indicating the information of a maximum of **three (3) officers and/or senior technical staff engaged in digital transformation, regulatory reform, or innovation in public administration—especially those with expertise or decision-making roles in governance, compliance, or the adoption and implementation of regulatory technologies.**
3. The Nominating Officer should be the Immediate Supervisor or a decision-maker from the agency/organization. He/she should sign the nomination form once completed.
4. The completed form must be emailed to [regtechconference2025@dap.edu.ph](mailto:regtechconference2025@dap.edu.ph) **on or before 15 September 2025 (Friday) 5:00 PM**, with the subject: [Agency Abbreviation] – Nomination Form (e.g., DOST – Nomination Form). Please copy the nominees.

### **Confirmation and Registration**

1. Accepted individuals will receive an email with the conference details and a link to the Registration Form which will request information relevant to the issuance of Certificate of Participation.
2. For accepted participants, registration is mandatory to secure a slot. Make sure to complete the registration form by **15 September 2025 (Monday), 5:00 PM**.
3. Upon registering, the participant will receive a final confirmation email with their digital ID and a QR code. This QR code will provide access to a common folder containing pertinent conference materials, such as the program schedule, RP profiles, and more.

### PROGRAM BRIEF

**Background:** Governments today face rising regulatory complexity amidst rapid technological advancement. Traditional, manual compliance systems are increasingly strained by growing data demands, real-time oversight requirements, and evolving rules. To address these challenges, Regulatory Technology (RegTech)—which harnesses AI, big data, and automation—offers the potential to streamline compliance, enhance risk management, and enable smarter governance.

As APO member economies adopt digital transformation to improve public service delivery, barriers such as institutional inertia, technological readiness gaps, and regulatory rigidity continue to limit progress. This conference aims to confront these issues head-on by facilitating knowledge-sharing, exploring emerging technologies, and identifying future-ready strategies for more adaptive, efficient, and integrated regulatory systems.

#### Objectives

1. Explore how digital transformation and RegTech can enhance public-sector productivity and regulatory efficiency;
2. Showcase AI-driven tools, best practices, and strategies to improve governance and service delivery;
3. Promote collaboration and cross-border learning among stakeholders in the region; and
4. Identify key policy directions, resource requirements, and implementation enablers for adopting and scaling RegTech solutions.
