#### NOMINATIONS FOR SEAMEO SECRETARIAT POSTS

The Southeast Asian Ministers of Education Organization (SEAMEO) Secretariat invites nominations for the positions of Policy and Planning Specialist and Publication and Multimedia Specialist, which are expected to become vacant in November 2025.

The nomination of applicants shall be facilitated by the Department of Education-International Cooperation Office (DepEd-ICO), while appointments shall be made by the SEAMES Director. Applicants must submit a completed application form along with supporting documents, including a curriculum vitae, certificates, references, and other relevant materials.

Selected candidates shall be provided with a formal Letter of Appointment, including the SEAMEO Staff Regulations, Rules, and Declaration of Office.

Staff members in the Professional category shall be appointed for a term of three years and may be eligible for reappointment. Employment in the Secretariat for professional staff shall be limited to two consecutive terms. In exceptional cases, a third term may be granted if the staff member has demonstrated excellent performance, as determined by the Director of the SEAMEO Secretariat.
