BUDGET OF WORK FOR THE MOST ESSENTIAL LEARNING COMPETENCIES FOR 3RD AND 4TH QUARTERS OF SCHOOL YEAR 2023-2024 IN ALL LEARNING AREAS ACROSS GRADE LEVELS

To: Assistant Schools Division Superintendent Chief Education Supervisors Heads, Public Elementary and Secondary Schools Heads, Unit/Section All Others Concerned

1. With reference to DepEd Order 21, s. 2019, Policy Guidelines on the K to 12 Basic Education Program dated August 22, 2019, DepEd Order 12, s. 2020, Adoption of the Basic Education Learning Continuity Plan for School Year 2020-2021 in Light of the Covid-19 Public Health Emergency, and Division Memorandum 040, s. 2024, Mapping of the Most Essential Learning Competencies (MELCs) for 3rd and 4th Quarters in All Learning Across Grade Levels, this Office, through the Curriculum Implementation Division, releases the Budget of Work for the Most Essential Learning Competencies for the 3rd and 4th Quarters of School Year 2023-2024 in all learning areas across grade levels.

2. The budget of work for the MELCs is based on the educational and social contexts of the schools division. Likewise, this shall serve as the guide of teachers to facilitate the teaching and learning process for learners to meet the standards set in the curriculum.

3. The number of days as stipulated in the budget of work shall be the minimum number of instructional time to master the corresponding most essential learning competencies. There shall be a total of 20 non-negotiable instructional days per quarter. Should there be excess class days for the quarter, these number of days shall be devoted and utilized to deepen the mastery of the learning competencies for the quarter.

4. To ensure effective and quality education for our learners, teachers are encouraged to apply the different pedagogical approaches that are constructivist, collaborative, inquiry-based, integrative, reflective, and differentiated in facilitating the teaching and learning process. Further, school leaders are directed to monitor the implementation of the budget of work for the MELCs.
