## **Enclosure 3**

### **Guidelines on the Selection of Learner-Participants**

#### **I. General Principle**

The selection of test takers for the PISA-like assessment shall adhere to **standardized, objective, and unbiased procedures** to ensure that assessment results are **valid, reliable, and representative** of learners' competencies across grade levels.

#### **II. Target Population**

The target population shall consist of **currently enrolled learners** in the following grade levels:

- Grade 4
- Grade 5
- Grade 7
- Grade 8

#### **III. Eligibility Criteria**

##### **1. Age Requirement**

Learners must be 15 years old at the time of testing (Year 2029), in accordance with PISA standards.

##### **2. Enrollment Status**

Must be currently enrolled in a recognized public secondary school during the testing period.

##### **3. School Attendance**

Must be a regular attendee of school and not on long-term leave or prolonged absence.

#### **IV. Sampling and Selection Guidelines**

##### **1. Random Selection**

Eligible learners shall be selected using a random sampling method from the official school enrollment.

No substitution shall be allowed except under valid and documented reasons (e.g., illness, transfer).

##### **2. Representativeness**

The sample should reflect the diversity of the student population, considering:

- Sex (e.g., 15 males, 15 females)
- Proficiency Level (10 learners from upper, 10 learners from middle, 10 learners from lower)



- Program offerings (e.g., regular, science-oriented programs)

## **V. Inclusion and Exclusion Criteria**

### **1. Included Learners**

- Learners with different academic ability levels.
- Learners with mild learning needs who can participate with reasonable accommodations.

### **2. Excluded Learners**

- Learners with severe disabilities that prevent meaningful participation even with accommodations.
- Learners with insufficient language proficiency in the test language, as determined by DepEd or school guidelines.

## **VI. Ethical and Administrative Considerations**

### **1. Informed Consent**

Parents/guardians and learners shall be informed about the purpose, scope, and procedures of the assessment.

Participation shall follow DepEd and institutional ethical standards.

### **2. Confidentiality**

Learner identities and individual results shall be kept confidential and used strictly for research, policy, and improvement purposes.

### **3. Standard Testing Conditions**

All selected test takers shall be assessed under uniform and standardized testing conditions to ensure comparability of results.

## **VII. Roles and Responsibilities**

### **1. School Head**

- Ensures accurate submission of the list of eligible learners.
- Oversees proper implementation of selection procedures.
- Submit the consolidated report of the post-test survey questionnaires/ feedback form.

### **2. Testing Coordinator**

- Conducts random sampling and documentation.
- Ensures adherence to prescribed guidelines.

### **3. School ICT Coordinator, Teachers and Staff**

- Assist the learners in creating Quipper Account and in enrolling to their specific class.
- Provide technical support whenever necessary during the pilot testing.

- Assist the learners in accomplishing the post-test survey questionnaires/ feedback form.
- Answer the post-test survey questionnaires/ feedback form.

## **VII. Documentation and Reporting**

The teacher PISA-like Pilot Testing Focal assign must maintain records of:

- Eligible learner lists
- Sampling procedures used
- Reasons for exclusions or substitutions

Submit reports to the Schools Division Office and Regional Office as required.
