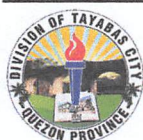

TECHNICAL TRIAL OF ONLINE TEACHING
USING GSV MODELS FOR OPEN BROADCAST SYSTEM

1. The challenge to respond to the urgent need to protect and promote the collective interests of all Filipinos in this challenging times, as stated in the *Bayanihan to Heal as One Act*, drove the Department of Education to issue **DepEd Order No. 12, s. 2020**, the *Adoption of the Basic Education Learning Continuity Plan (BE-LCP) for SY 2020-2021 in Light of the COVID-19 Public Health Emergency*.
2. The BE-LCP, as a package of education interventions enjoined internal and external stakeholders in designing learning delivery strategy, in compliance with the guidelines of Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF), provides the link to DepEd's pivot to quality under the framework *Sulong Edukalidad*.
3. In light of the above, a core group (See attached list) shall take the lead in using Open Broadcast System (OBS) in conducting online classes, with GSV Models (GSV Model 1 using Smartphone; GSV Model 2 using Webcam; GSV Model 3 using Camera).
4. For the technical trial using OBS, three teachers from Luis Palad Integrated High Schools, namely: Mrs. Jovie Daelo, Mrs. Rona Elarco, and Mr. Neil Talavera shall participate using their respective online classes, on August 3-6.
5. The output of this technical trial shall serve as a prototype to lead the core group in crafting a recommendation to utilize the OBS GSV Models during capacity-building activities, whenever appropriate, to be initiated later by the Division Offices and by the different schools during SLAC (School Learning Action Cell) sessions.
6. Immediate and wide dissemination of this memorandum is desired.

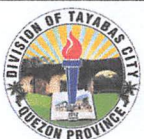
