# PSYCHOEDUCATIONAL ASSESSMENT OF LEARNERS WITH DISABILITIES/DIFFICULTIES (LWDS)

To: Assistant Schools Division Superintendent Chief Education Supervisors Heads, Public and Private Elementary Schools Heads, Unit/Section All Others Concerned

- 1. In adherence to DepEd Order No. 44, s. 2021, re: Policy Guidelines on the Provision of Educational Program and Services for Learners with Disabilities in the K to 12 Basic Education Program, this Office informs all concerned that the administration of Psychoeducational and Developmental Assessment of Learners with Disabilities/Difficulties (LWDs) by the Educational Psychologists will be on June 2025. This is in partnership with Disability Affairs Unit of the City Social Welfare and Development Office.
- 2. The activity's goal is to gather information/data to determine the learner's current level of functioning, including but not limited to cognitive, motor, psychosocial, communication, and adaptive skills, as a foundation for clearly establishing the goals for LWD's learning and development areas required to create the learner's Individualized Education Plan (IEP).
- 3. All schools with identified Learners With Difficulties/Disabilities must submit the required documents (**Enclosure 1**) to Mrs. Mildred Z. Galleno, Education Program Supervisor in charge of Special Needs Education (SNED) on or **before May 26, 2025.**
- 4. Immediate dissemination of this Memorandum is desired.
