RESUMPTION OF THE DELIVERY OF MEDICAL, DENTAL AND NURSING SERVICES IN SCHOOLS PARTICIPATING IN THE PILOT IMPLEMENTATION OF LIMITED FACE TO FACE CLASSES

To: **OIC-Assistant Schools Division Superintendent** Chief Education Supervisors Heads, Public Elementary and Secondary Schools Heads, Unit/Section All Others Concerned

Pursuant to OUA Memorandum No. 00-0322-0020 with the subject: 1. Resumption of the Delivery of School-Based Health Services in Schools Participating in the Pilot Implementation of Limited Face-to-Face Classes, wherein all schools are directed to resume the delivery of school-based health services to learners, the School Health Section - Medical and Dental Unit shall continue to conduct health inspection (medical and dental examination) of learners and continue the delivery of medical, dental and nursing services to learners, teaching and non-teaching personnel at the SDO Tayabas Clinic and SDHCP Clinics at Kalumpang Elementary School and Tayabas East Central School.

The consent of the learners' parents shall be secured in services where 2. they are required (e.g. provision of medical and dental treatment).

The delivery of dental services to learners will be by schedule and will be 3. arranged by the Dentist II on the SDHCP clinics. The list of learners to be treated are identified based on the dental examination conducted and those learners reported by the School Head or Health Coordinator whose attendance to schools are affected by urgent dental concerns.

The delivery of medical services to learners will also be by schedule and 4. will be arranged by the Nurse II or by the Medical Officer III on the SDHCP Clinics and can be done in conjunction with the schedule of dental consultation or vice versa. The list of learners to be treated are identified based on the medical examination conducted and those learners reported by the School Head or Health Coordinator who are afflicted by medical concerns resulting in poor attendance to schools and poor learning outcomes.

5. The School Head of each SDHCP Clinics will be notified on the schedule of medical and dental appointment of learners to be treated. Tayabas East Central School will serve the learners from the East District and Kalumpang Elementary School will be for the learners in the West District. Moreover, this project can also be augmented by the Medical and Dental Teleconsultation Services pursuant to Division Memorandum 182 S. 2023.

6. All involved shall strictly observe the required health standards in the delivery of services.
