1. To assist the Department of Education (DepEd), particularly its Learning System Strand, in the implementation of its programs and initiatives; to strengthen inter-agency coordination; and to advance education and workforce development reforms, **Dr. Karol Mark R. Yee** is designated as **Special Technical Advisor** to the Learning System Strand of DepEd.

2. In his capacity as Special Technical Advisor, Dr. Yee shall provide technical expertise and advisory support. He shall undertake the following functions:

- a. Provide technical advice and strategic policy inputs on matters relating to education reform and workforce development;
- b. Participate in inter-agency meetings, workshops, and coordination activities;
- c. Assist in the review of policy directions, roadmaps, and programs;
- d. Provide advisory inputs and technical guidance to support the work of relevant government agencies;
- e. Perform such other functions as may be necessary to ensure the proper and efficient implementation of strategic policies of DepEd at the discretion of the Secretary.

3. The authority granted to Dr. Yee shall be strictly limited to technical and advisory functions and shall not include any role involving operational decision-making, procurement, financial management, or administrative supervision within DepEd.

4. Dr. Yee shall not be entitled to honoraria and compensation from DepEd.

5. As Special Technical Advisor, Dr. Yee shall sign official correspondence in the following manner:

6. This designation shall be undertaken in a manner that avoids any conflict of interest with Dr. Yee's official duties as Executive Director of EDCOM II and shall be subject to applicable laws, rules, and ethical standards governing public officials and employees, including Republic Act No. 6713 (Code of Conduct and Ethical Standards for Public Officials and Employees) and relevant Civil Service Commission regulations.

7. If any provision of this Memorandum is declared invalid, the remaining provisions shall continue to be in full force and effect.

8. This Memorandum shall take effect immediately upon its approval and issuance.
