

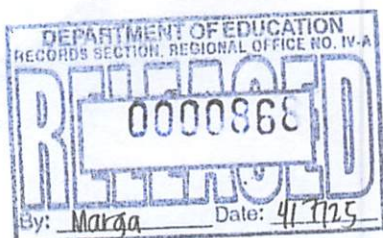

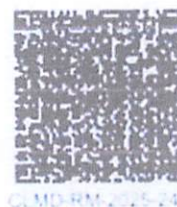

IMPLEMENTATION GUIDELINES ON THE UTILIZATION OF REMEDIATION READING PACKAGES

A. Distribution and Utilization

1. The English Reading Kit and WIKAHON shall be distributed to designated schools following a thorough needs assessment conducted by each SDO to ensure equitable allocation of resources.
2. Schools shall incorporate these materials into structured reading remediation sessions, ensuring alignment with the National Reading Program to maximize their impact on students' reading proficiency.

B. Orientation and Training

1. A comprehensive orientation on the effective utilization of the English Reading Kit and WIKAHON shall be conducted per SDO to equip educators with essential knowledge and strategies for implementation.
2. Attendance and active participation of all concerned teachers and personnel are mandatory to guarantee the successful adoption and execution of the reading packages.

C. Monitoring and Evaluation

1. Division English and Filipino Coordinators shall take the lead in monitoring and ensuring the proper implementation of these reading packages, providing guidance and support where necessary.
2. Schools shall submit monthly reports detailing the progress, challenges, and effectiveness of the remediation activities to assess the impact of the intervention.
3. The Regional Office shall conduct periodic monitoring visits and extend technical assistance to strengthen the implementation of reading interventions.

D. All concerned personnel are strongly encouraged to proactively implement these reading remediation strategies to foster literacy development among learners.
