## CALL FOR SUBMISSION OF PERTINENT DOCUMENTS FOR RECLASSIFICATION OF TEACHER II, III AND MASTER TEACHER I, II [ELEMENTARY AND SECONDARY (JHS)]

To: OIC-Assistant Schools Division Superintendent Chief Education Supervisors Heads, Public Elementary and Secondary Schools Heads, Unit/Section All Others Concerned

1. As a way of motivating our human resources to continuously improve their effectiveness and efficiency in delivering quality, accessible, relevant and liberating basic education, this Office reminds/ announces to the field that the Office of the Schools Division Superintendent through HRMO is ongoing on accepting application documents for reclassification T II/T III and Master Teacher I/II.

## 2. Reclassification of Teacher II/III through Equivalent Record Form (ERF)

Applicants may come from Elementary and Secondary (JHS). Checklist of requirements for ERF can be downloaded at SDO Tayabas website. <u>https://tinyurl.com/Checklist-reclassification</u>

## 3. Reclassification of Master Teacher I/II

Total number of Master Teacher position shall not exceed 10% of the total authorized teacher positions in the school, to wit:

- Master Teacher I position shall not exceed 6.6% of the total number of authorized teaching positions.
- Master Teacher II position shall not exceed 3.3% of the number of authorized Master Teacher I positions.
- For Secondary to be distributed to the learning areas/ subject area using the required number of teachers per department (5+1).
- School should submit the fully furnished copy of Ranklist for the current school year with the forwarded pertinent documents to the division office.
