1. As stated in **DM-CI-2020-00029** dated June 4, 2020 entitled: "*Proposed DepEd Teaches*", the Office of the Undersecretary for Curriculum and Instruction proposes to launch the "**DepEd Teaches**".
2. This initiative supports the current efforts of the Department of Education in communicating with the various stakeholders and in the professional updating of the school officials and teachers in the various field units. The intention of the project is to allow teachers to enrich their knowledge on curriculum, learning delivery, and assessment at their most comfortable time. In addition, school officials will be provided updates on their main task of leading and learning.
3. The DepEd Teaches aims to provide teachers and school officials an array of videos that will improve their knowledge and broaden their perspective on learning and school management through the lens of the DepEd officials and renowned teachers who will facilitate the discussion. Specifically, it aims to promote an online platform for DepEd to engage teachers, and other members of the DepEd family in an online learning community.
4. To ensure that the topics to be tackled for the webinars to be launched are relevant and expedient to the demands of time, this Office initiates a needs assessment through an online survey form. The survey form contains 1) questions relative to the demographic profile of the respondent and 2) a 38-item questionnaire covering the different pedagogical indicators in teaching and learning.
5. In this light, all teachers are enjoined to accomplish the online survey form using the link bit.ly/DepEdTeaches on or before **December 4, 2020**.
6. Rest assured that the responses to be gathered in the survey form shall be treated in accordance to the provisions stipulated in RA 10173 or the Data Privacy Act of 2012 and shall only be used for "DepEd Teaches" only.
