ORIENTATION ON CONTACT TRACING, REFERRAL AND MANAGEMENT OF COVID-19 CASES IN DEPED TAYABAS CITY

To: **OIC-Assistant Schools Division Superintendent Chief Education Supervisors** Education Program Supervisors Heads, Unit/ Section Heads, Public Elementary and Secondary Schools All Others Concerned

Relative to Regional Memorandum No. 471, s. 2020, the Department of 1. Education CALABARZON IV-A has been monitoring the COVID-19 Cases of teaching, non-teaching and learners in the Region since March 2020, and a rapid rise of cases has been noted since the lifting of ECQ in July 2020 and even there is no face-toface classes, nearly 49% of 483 confirmed cases are learners. As part of Covid-19 intervention and to further empower the Division on the pursuit of learning continuity during the time of emergency, the SDO Tayabas through the SGOD Medical and DRRM Team will conduct an Orientation on Contact Tracing, Referral and Proper Management of Covid-19 Cases in DepEd Tayabas City on December 18, 2020 from 8:30 to 12 noon (1st batch) and 1:00 to 4:30 pm (2nd batch).

2. The said event will be conducted simultaneous via face to face and virtual. This orientation aims to:

a. Orient the participants on Contact Tracing, Referral and Management of Covid-19 Protocols.

b. Discuss Data Privacy Act and handling data confidentiality.

c. Discuss strategies on how to facilitate data sharing at the LGU level.

d. Provide avenue for clarifications.

Participants are SDO Personnel, School Heads, School Health and 3. Nutrition Coordinators and SDRRM Coordinators. SDO Personnel are expected to attend physically on December 18, 2020 at GSU Building while the School Heads. School Health and Nutrition Coordinators and SDRRM Coordinators are expected to attend via online (link will be sent to respective group chats a day before the event).
