1. Pursuant to Sections 6, 8, 9, and 10 of Rule II of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 10588 otherwise known as the Palarong Pambansa Act of 2013, the Department of Education (DepEd), in coordination with the Philippine Sports Commission (PSC) and the Department of the Interior and Local Government (DILG), shall conduct the **2026 Palarong Pambansa** in the Province of Agusan del Sur, from May 24 to 31, 2026.

2. With this year's theme, Unlocking the Future Through Sports, the annual national scholastic multi-sport competition shall be hosted by the Provincial Government of Agusan del Sur (PGAS) together with the DepEd-CARAGA Region and the Schools Division Office (SDO) of Agusan del Sur.

## 2026 PALARONG PAMBANSA GENERAL INFORMATION

The **66th edition of the Palarong Pambansa**, with the theme “Unlocking the Future Through Sports”, is scheduled from May 24 to May 31, 2026, and shall be hosted by the Provincial Government of Agusan del Sur (PGAS) together with the DepEd-CARAGA Region and the Schools Division Office (SDO) of Agusan del Sur.

For the **Opening Ceremony**, each delegation shall prepare two (2) pieces of 3x5 ft banners—one to be used during the parade and another for the banner raising ceremony—and shall adopt one common *Saludo* song, *The Ultimate Palaro Dream*, to ensure unity and synchronization throughout the ceremony. Each delegation is likewise encouraged to present its own icon or hero (mascot) to showcase identity, while strictly observing the maximum participation of **three hundred (300) delegates per delegation** during the parade to maintain order, safety, and smooth flow of the ceremony.

All regions are directed to maintain a lean and strictly need-based delegation, in line with the DepEd OSEC Memorandum (*Directive on Streamlined Delegation and Adherence to Energy Conservation Standards on the Conduct of Significant National and Regional Events*). This directive supports Office of the President Memorandum Circular No. 114, which calls on all government agencies and instrumentalities to strictly implement energy-conservation measures in response to the ongoing global energy crisis.

## Sports to Compete

- The official regular sports in the elementary and secondary level, as provided in Section 27 of Rule VI of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 10588 otherwise known as the *Palarong Pambansa Act of 2013* and through previous *Palarong Pambansa* Board Resolutions, shall remain to be played in this edition of the *Palarong Pambansa*, as follows:

- Weightlifting** will be featured as a regular sport, while **Karate**, **Kickboxing**, and **Soft Tennis** as demonstration sports; and **Muaythai** and **Paragames events (Sitting Volleyball & Table Tennis)** as exhibition sports in this year's *Palarong Pambansa*.

- There shall be separate events for student-athletes with special needs such as **Para-Athletics, Para-Swimming, Bocce,** and **Goalball.** Medals shall be awarded to the winners of the said special games.
- Tribalypics** will also be featured in the 2026 *Palarong Pambansa* to promote the Philippine indigenous games, as well as preserve and appreciate the cultural heritage of Filipino indigenous people among our learners.
- All regions are requested to actively participate in the Tribalypics and Exhibition Sports by sending **15 to 20 representatives** from their respective delegations.

## Screening & Accreditation

- The National Screening and Accreditation Committee (NSAC) for this year's *Palarong Pambansa* is hereby constituted by the *Palarong Pambansa* Board to conduct the screening and accreditation of athletes, coaches, assistant coaches, and chaperones submitted by the participating regional delegations, pursuant to OUOPS Memorandum entitled *Guidelines on the Eligibility of Athletes in the Division, Regional, and National Level for the 2026 Palarong Pambansa.* All other issuances inconsistent with the aforementioned guidelines are hereby rescinded.
- Members of the National Training Pool and National Developmental Pool who are duly recognized and bona fide enrollees in basic education (elementary and secondary) shall be allowed to participate in this year's *Palarong Pambansa.*

## General Competition Guidelines

- The **Home Region Representation Rule** shall be adopted in this year's *Palarong Pambansa* where it requires a student-athlete to represent his or her home region in team events at the *Palarong Pambansa*, notwithstanding his/her participation during the Division or Regional Meets, subject to the guidelines

issued by this Department. The purpose of this Rule is to uphold fairness and integrity in the *Palarong Pambansa* by ensuring that student-athletes compete for the region where they are academically residing for a specified period of time. This rule also helps preserve the authentic identity of each region's teams.

9. As a reiteration, this year's *Palarong Pambansa* shall adopt the **Modified Winner-Take-All policy** for all team sports (Basketball, Baseball, Softball, Football, Futsal, Sepak Takraw and Volleyball) and the **Qualifying Standards** for measurable sports such as Athletics, Swimming, and Archery.
10. The **top two (2) qualifiers** in measurable sports shall advance to the 2026 *Palarong Pambansa* national level of competition. However, in the absence of qualifiers, the gold medalists may represent the region in the national games.
11. To ensure the safety and well-being of athletes, outdoor games shall observe a **window period between 10:00 a.m. and 03:00 p.m.** to avoid exposure to intense heat. Should adverse weather conditions such as heavy rains or extreme temperatures arise, the Tournament Directors, together with the host LGU, may recommend suspending the games for a specified time. Any adjustments to schedules or venues shall require approval from the *Palarong Pambansa* Secretary General, provided that competitions must still be completed within the prescribed schedule.
12. Consistent with DepEd's existing policies and guidelines in resolving **protest on game technicalities** of any sports event and **protest on eligibility**, complaints should be in written form, with affidavits of witnesses and/or evidence to support the same. There shall be **no protest fee** to be collected from the protesting regional delegation.

## Awards & Recognition

13. The **Olympic Medal System** shall be applied. The total number of gold, silver, and bronze medals at stake in the different sports events is provided in Enclosure No. 9.
14. Medals awarded in the demonstration sports shall not be included in the medal count earned by the regional delegation.
15. The top 5 regional delegations shall be recognized based on the overall standings in the official medal tally. However, recognition will be bestowed, as well, to the top performing regional delegations in each sport played in the 2025 *Palarong Pambansa*.
16. The top 5 SDOs/LGUs shall also be recognized based on their total medal haul in the 2025 *Palarong Pambansa*.
17. The following may be given cash incentives, pursuant to Section 15 (b) of DepEd Order (DO) No. 43, s. 2016 entitled *Implementing Rules and Regulations of Republic Act 10588 or the Palarong Pambansa Act of 2013*, subject to the availability of funds and in accordance with the usual accounting and auditing rules and regulations:
  - a. 2026 *Palarong Pambansa* medalists and new record holders in regular sports events including the top three winners in the special games; and

- b. Technical officials and other personnel who served in the conduct of the 2026 *Palarong Pambansa*.
18. **Cash incentives** for medalists in the 2026 *Palarong Pambansa* shall be provided courtesy of the Philippine Sports Commission (PSC), in recognition of the outstanding achievements and exemplary performance of student-athletes.

### National Technical Working Committees & Technical Officials

19. The 2026 *Palarong Pambansa* Organizational Structure containing the list of members of the *Palarong Pambansa* Board, National Executive Committee and Steering Committee, and the various national technical working committees is provided under Enclosure No. 2 of this DepEd Memorandum.
20. All DepEd personnel who will serve in the 2026 *Palarong Pambansa* as accredited technical officials or members of the various national technical working committees are required to register online. The online registration may be accessed through: <https://bit.ly/2026PalarongPambansaRegistrationForm>.
21. All members of the various national technical working committees and technical officials must satisfy all the requirements provided in the enclosed Guidelines on the Selection of Members of the National Technical Working Committees in the 2026 *Palarong Pambansa* (Enclosure No. 4) and Guidelines on the Selection of Technical Officials in the 2026 *Palarong Pambansa* (Enclosure No. 5), respectively.
22. The following documentary requirements shall be presented by the selected technical officials upon registration:
- a. Authority to Travel documents:
    - i. **For DepEd employees** – approved travel authority duly signed by their respective heads of office;
    - ii. **For National Sports Association (NSA) members** – official letter from the Association President or Secretary General (or any duly authorized NSA official) authorizing their participation;
    - iii. **For officials/personnel from the Host Local Government Unit (LGU)** – letter of endorsement from the Local Chief Executive, City/Provincial Administrator, or authorized official in charge of 2026 *Palarong Pambansa*;
    - iv. **For PSC employees** – official Travel Order signed by the PSC Executive Director; and
    - v. **For technical experts from other private organizations** – signed conforme letter.
  - b. Two (2) recent **2" x 2" ID pictures**;
  - c. **Medical certificate** issued by a government physician certifying that he/she is physically fit and able to serve during the *Palarong Pambansa*; and
  - d. **Full Disclosure Form** (for technical officials).
23. Failure to submit all abovementioned documents shall be a ground for denial of registration.

24. The members of the various national technical working committees and technical officials are advised to arrive in Agusan del Sur Province not earlier than **May 18, 2025**.
25. All members of various technical working committees may be given additional subsidies – on top of the allowable expenses to be given – as may be authorized, charged against the Physical Fitness and School Sports (PFSS) Funds, subject to the existing government accounting and auditing rules and regulations.
26. All DepEd personnel who will serve in the 2026 *Palarong Pambansa* as accredited technical officials or members of the different national and local working committees shall be granted vacation leave credits pursuant to the provisions of DepEd Order No. 13, s. 2024 entitled *Revised Guidelines on Grant of Vacation Service Credits to Teachers*.
27. Transportation expenses of all members of the various national technical working committees and technical officials from their respective stations/offices to Agusan del Sur Province and back shall be charged against the Physical Fitness and School Sports (PFSS) Funds, subject to the existing government accounting and auditing rules and regulations. They shall also be provided with a meal allowance during their actual official stay. All members of various technical working committees and technical officials **must use the most economical and austere means of transportation**.

### **Guidelines on the Safety and Welfare of Regional Delegations**

28. To ensure the safety and well-being of all participants, the regional delegations shall comply with the minimum and augmented health personnel deployment standards for the 2026 *Palarong Pambansa*, as detailed as follows:

#### **Recommended Operational Staffing for *Palarong Pambansa***

In view of the multi-venue, high-risk, and time-sensitive nature of the event, the following augmented deployment is recommended:

- i. Four (4) Medical Officers
- ii. Fifteen Nurses
- iii. One (1) Dentist

29. The Bureau of Learner Support Services–School Health Division (BLSS-SHD) shall provide Program Support Funds (PSF) to help defray and supplement the allowable expenses related to the deployment of health personnel of regional delegations serving in the 2026 *Palarong Pambansa*.
30. All regions shall provide personal accident insurance coverage to all the members of its delegation, which will cover the period from departure to arrival at the respective stations.
31. All regions shall adhere to the provisions of DepEd Order (DO) No. 40, s. 2012 (DepEd Child Protection Policy). Therefore, all regional delegation officials shall be accountable for the protection, welfare, and safety of their student-athletes. In addition, each of the DepEd regional offices shall provide medical insurance coverage for its respective members of the delegation.
32. In compliance with DO 13, s. 2017 entitled *Policy and Guidelines on Healthy Food and Beverage Choices in Schools and in DepEd Offices*, all regional delegations

shall promote healthy eating habits by making available healthy and nutritious food and beverages during the 2026 *Palarong Pambansa*.

33. The **No Alcohol, No Smoking, and No Gambling Policy** of this Department shall be strictly observed for the duration of the 2026 *Palarong Pambansa*. Violators shall be dealt with accordingly.
34. The **Clean As You Go (CLAYGo)** principle must be strictly followed by all participants in the 2026 *Palarong Pambansa* to ensure a clean, hygienic, safe, and organized environment (billeting schools, playing venues, workplace, etc.). The use of reusable materials such as tumblers, eating utensils, among others is also highly encouraged.
35. The regional directors/heads of the regional delegations are enjoined to lodge and stay with their respective delegates in the assigned billeting school/s.

### **Consent, Waiver, Indemnity, and Release on the Use of Images and Video Recordings**

36. By participating in *Palarong Pambansa*, all athletes, coaches, officials, and attendees acknowledge and grant DepEd the right to use, display, exhibit, reproduce, distribute, and create derivative works from these materials in any media now known or developed in the future.
37. To formalize this acknowledgment, all participants are required to sign the waiver enclosed in this Memorandum (Enclosure No. 11), granting DepEd the necessary permissions for the use of images and recordings taken during the event.

SUBJECT : **GUIDELINES ON THE CONSTITUTION OF THE NATIONAL TECHNICAL WORKING COMMITTEE FOR THE 2026 PALARONG PAMBANSA**

DATE : **25 March 2026**

The Department of Education (DepEd), in coordination with the Philippine Sports Commission (PSC) and the Department of the Interior and Local Government (DILG), shall conduct of the **66th edition of the Palarong Pambansa** this year to be hosted by the Provincial Government of Agusan del Sur (PGAS).

In preparation for this year's annual scholastic multi-sport event, this Office, through the *Palarong Pambansa* Secretariat, shall convene various **National Technical Working Committees** (NTWCs) to assist in the preparation, coordination, and implementation of all necessary activities.

In regard thereto and to ensure efficient operations and prudent management of resources, this Office issues these guidelines to streamline committee composition and reinforce adherence to the *Directive on Streamlined Delegation and Adherence to Energy Conservation Standards on the Conduct of Significant National and Regional Events*.

**I. GENERAL GUIDELINES**

**A. Maintaining a Lean NTWC Structure**

1. Each NTWC shall be composed only of personnel whose roles are essential to carrying out the committee's technical, administrative, or operational functions.

2. NTWC chairpersons/heads must exercise prudence by choosing only individuals whose duties are directly relevant to the deliverables of the committee.

#### **B. Alignment with Functional Expertise**

1. Recommended members of the NTWC should have the appropriate expertise, functional roles, or relevant experience that aligns with the specific needs of the committee they will be part of.
2. Membership recommendations must assure that each personnel have a clear and necessary contribution to committee outputs.

### **II. SPECIFIC PROVISIONS**

#### **A. Inclusion and Exclusion of Personnel as NTWC Members**

1. Drivers shall not be included as members of any NTWC, as their primary duty is to exclusively provide driving services and transport their principals from one place to another.
2. Executive Assistants and Technical Assistants (EAs and TAs) shall likewise not be included, except for EAs and/or TAs who have been officially designated and approved as NTWC members based on their assigned functional roles. For these personnel, the recommending office must provide justification demonstrating their direct contribution to the committee's tasks.
3. If any office opts to deploy drivers, non-designated EAs and/or TAs, or other personnel not authorized under these guidelines for internal or operational purposes, all expenses related to their participation such as travel, accommodation, per diem, and other incidental expenses shall be charged against their respective local funds.

### **III. ROLES AND RESPONSIBILITIES**

#### **A. Palarong Pambansa Board**

1. The *Palarong Pambansa* Secretary General, as the official representative of the *Palarong Pambansa* Board, approves the final composition of the NTWC (chairpersons/heads and members) for the 2026 *Palarong Pambansa*.

#### **B. NTWC Chairpersons/Heads**

1. Review and endorse committee members in accordance with these guidelines.
2. Ensure that each recommended personnel have a clearly defined and necessary role and that his/her functions are aligned with the needs of their assigned committee.

### C. *Palarong Pambansa* Secretariat

1. Review all proposed NTWC composition for completeness and adherence to the streamlined delegation directive.
2. Recommend revisions to NTWC composition when necessary.
3. Facilitate final approval and maintain updated list of NTWC members.

### D. NTWC Members

1. Perform duties and responsibilities in accordance with the approved Terms of Reference (TOR) of their respective committees and carry out additional tasks as may be assigned by the *Palarong Pambansa* Secretary General, *Palarong Pambansa* Secretariat, or committee chairpersons/heads.
2. Participate in coordination meetings and other 2026 *Palarong Pambansa*-related undertakings where their attendance is required.
3. Contribute to timely submission of reports, documentation, and committee outputs.

## IV. COMPLIANCE

1. All DepEd personnel who will serve as members of the NTWC in the 2026 *Palarong Pambansa* shall ensure strict adherence to these guidelines.
2. Any deviation must be accompanied by a written justification and shall be subject to review by the *Palarong Pambansa* Secretariat and the designated approving authority.
3. Supplemental advisories may be issued as needed to clarify or reinforce the implementation of these guidelines.

Immediate dissemination and strict compliance with this Memorandum are directed.

**SUBJECT : GUIDELINES ON THE SELECTION OF TECHNICAL  
OFFICIALS FOR THE 2026 PALARONG PAMBANSA**

**DATE : 25 March 2026**

The Department of Education (DepEd), in coordination with the Philippine Sports Commission (PSC) and the Department of the Interior and Local Government (DILG), shall conduct of the **66th edition of the Palarong Pambansa** this year to be hosted by the Provincial Government of Agusan del Sur (PGAS).

In line with this, the Office hereby issues the following **Guidelines on the Selection of Technical Officials** who will serve in their respective sports during the 2026 *Palarong Pambansa*.

**I. SELECTION OF TECHNICAL OFFICIALS**

Regions that will be recommending their respective technical officials to serve in the 2026 *Palarong Pambansa* shall observe the following guidelines:

- a. The individual must come from the pool of **Class A and B+** technical officials based on the results of the **2023 and 2025 National Accreditation of Technical Officials (NATO)**;
- b. All regions are directed to prioritize the endorsement of technical officials from their respective **Class A** pool who will serve in the 2026 *Palarong Pambansa*. In case of an absence of available Class A technical officials for certain sports, regions are encouraged to endorse qualified personnel from their **Class B+** pool to ensure that all required slots are adequately filled;

- c. In cases where the highest classification for a sport is **B**, the region may recommend such technical official provided it has been vetted and approved by the tournament director to qualify to officiate;
- d. If there are no available Class A, B+, or B, the technical official slot of the region for that particular sport will be waived;
- e. **Class B-** and **C** technical officials are **not allowed** to officiate in the 2026 *Palarong Pambansa*;
- f. Waived regional slots for technical officials will be given to the host region or nearby regions, whichever has the slot for Class A or B+, provided it has been vetted and approved by the tournament director to qualify to officiate;
- g. The recommended technical official must be **55 years old** and below in the year of the *Palarong Pambansa*, and must be **physically fit** to officiate; and
- h. Must secure **medical clearance** to officiate in the 2026 *Palarong Pambansa* from a licensed physician of any government medical facility.

All selected tournament officials shall, upon registration, submit and execute a **Full Disclosure** statement detailing any conflicts of interest, relevant information, or other material facts that may affect their officiating responsibilities or decision-making in relation to any competing student-athlete in the 2026 *Palarong Pambansa*.

The technical official guarantees that the information they provide is accurate to the best of their knowledge and failure to do so may be a valid ground for disqualification as a technical official in the 2026 *Palarong Pambansa*. A sample disclosure form is enclosed herewith as Annex A.

## II. SELECTION OF MEMBERS OF THE CORE GROUP

Tournament Directors who will be recommending the respective members of their core group to serve in the 2026 *Palarong Pambansa* as technical consultants or personnel shall observe the following guidelines:

- a. Aside from the Tournament Director, Assistant Tournament Director, and Tournament Secretary, the core group shall likewise be composed of the designated **technical personnel/experts** for the respective sport;
- b. Must be **highly competent** and **possess specialized skill** in the respective sport;
- c. Preferably a **technical person from a national sports association (NSA)** duly recognized by the PSC and Philippine Olympic Committee (POC); and
- d. May not have undergone the National Accreditation and no age limit required provided that the recommended personnel is **physically fit** to

serve in the 2026 *Palarong Pambansa*, evidenced by a **medical clearance** issued by a licensed physician.

- e. If a DepEd personnel is recommended as a member of the core group, his/her selection must be vetted and approved by the respective regional office.

### III. ROLES AND RESPONSIBILITIES

#### A. *Palarong Pambansa* Board

1. The *Palarong Pambansa* Secretary General, as the official representative of the *Palarong Pambansa* Board, approves the final list of technical officials per sport for the 2026 *Palarong Pambansa*.

#### B. Regional Sports Officers

1. Recommend qualified technical officials for each sport, ensuring that selections follow the established guidelines and uphold the standards expected for the 2026 *Palarong Pambansa*.
2. Facilitate the provision of support for the logistical and operational needs of the technical officials, making sure they have the necessary resources and assistance to effectively carry out their duties throughout the sports event.

#### C. Tournament Directors

1. Ensure that all recommended technical officials and members of the core group are qualified to serve in the 2026 *Palarong Pambansa*, and that their expertise will be effectively utilized to support the smooth, efficient, and successful management of the tournament.

#### D. *Palarong Pambansa* Secretariat

1. Conduct a review of all technical officials recommended by the regional sports officers, ensuring that all selections align with the aforementioned guidelines.
2. Recommend revisions to list of technical officials for each sport when necessary.
3. Facilitate final approval and maintain updated list of technical officials for the 2026 *Palarong Pambansa*.
4. Provide the necessary assistance to the technical officials to ensure their optimal performance in their respective competitions.

#### E. Technical Officials

1. Perform duties and responsibilities in accordance with his/her terms of reference (TOR) and carry out additional tasks as may be assigned by the Tournament Director/Assistant Tournament Director.

2. Enforce rules, technical guidelines, and ground rules consistently and impartially.
3. Ensure safety, order, and proper conditions of the playing venue throughout the competition.
4. Uphold professionalism, integrity, and respectful communication at all times.

#### IV. COMPLIANCE

1. All DepEd personnel who will serve as technical officials in the 2026 *Palarong Pambansa* shall ensure strict adherence to these guidelines.
2. Any deviation must be accompanied by a written justification and shall be subject to review by the *Palarong Pambansa* Secretariat and the designated approving authority.
3. Supplemental advisories may be issued as needed to clarify or reinforce the implementation of these guidelines.

Immediate dissemination and strict compliance with this Memorandum are directed.

## **2026 PALARONG PAMBANSA GUIDELINES & PROTOCOLS (HEALTH, SAFETY, & WELFARE)**

### **I. HEALTH PROTOCOLS**

#### **A. PRE-EVENT**

1. All learner-athletes, coaches, chaperones, officials, technical committee members, and other *Palarong Pambansa* delegates shall secure a medical certificate of physical fitness duly certified by a government physician. The certificate shall be valid for three (3) months prior to the event.
2. To ensure equitable access to quality health services during an emergency (Republic Act No. 11223, or the Universal Health Care Act), all delegates and learner-athletes must be registered under a PhilHealth YAKAP provider before the event.

1. All learner-athletes shall undergo rapid screening and a brief review of systems to check for present health condition upon arrival in the host province using the checklist template provided: <https://bit.ly/Paloro2026ReviewofSystems>.

If a learner-athlete is deemed "Not Fit to Play" by the attending health professional, the learner-athlete shall not be allowed to participate in any sporting event until proper re-assessment is done by a health professional. Such medical determination shall be final and conclusive, and not subject to waiver, appeal or override by any non-medical personnel.

2. The host region, through the host school, shall ensure the availability of a first aid station with basic medical supplies (<https://tinyurl.com/BasicMedicalSupplies2026List>) and equipment. Psychological First Aid (PFA) providers shall also be available to respond to any mental health crises during the event.
3. DepEd Regional Offices (RO) shall ensure sufficient number of health personnel – at least 4 medical officers, 1 dentist, and 15 nurses.
4. The host school, in coordination with the regional delegation, shall designate an isolation area for any member of the delegation who manifests signs or symptoms of a communicable disease.
5. Health education on food safety shall be conducted, and the consumption of food from uncertified vendors is discouraged. Delegates are strongly advised to purchase food only from vendors or food establishments with a valid food safety certification or sanitary permit issued by the appropriate local authority.

6. Local importation or procurement of meat and meat products for the event shall comply with existing national and local regulations, including those issued by the National Meat Inspection Service (NMIS) and the local Veterinary Office. Coordination with these agencies is required to ensure proper inspection, certification, and handling to prevent the spread of zoonotic and foodborne diseases.
7. Billeting quarters must conform to WASH standards per DepEd Order (DO) 10, s. 2016 (Comprehensive Water, Sanitation and Hygiene in Schools Program), including, but not limited to:
  - a. Safe drinking water with water testing results and valid certification, free from coliform and E. coli;
  - b. Handwashing facilities;
  - c. Gender segregated toilets; and
  - d. Proper waste management.
8. All delegates, learner-athletes, and organized activities must adhere to the Joint Administrative Order No. 2022-0001 (Guidelines Healthy Settings Framework in Learning Institutions), DO 48, s. 2016 (Comprehensive Tobacco Control Policy), and DM III, s. 2019 (Prohibiting the Use of E-Cigarettes) which enforces the following:
  - a. No Smoking/No Vaping signages shall be displayed in billeting areas/ playing venues;
  - b. Delegations shall not have partnerships or sponsorships from industries promoting tobacco, vape, breast milk substitutes, or alcoholic beverages;
9. Similarly, the host region through the DOH/Provincial Health Office/City Health Office shall ensure the following:
  - a. Sufficient LGU health personnel manpower at billeting and playing venues;
  - b. Established protocols and process flow for referrals and medical case management;
  - c. List of hospitals/medical facilities with complete contact information for referrals and emergency cases;
  - d. Provision of ambulances at all billeting quarters and playing venues;
  - e. Monitoring and reporting of cases; and
  - f. Enforcement of a 100-meter no-sale and no-advertisement zone for tobacco, nicotine-laced, alcohol, and related products around schools.

## **I. DURING EVENT**

### **A. PRE-EVENT**

#### **1. Billeting Area**

- a. The host school shall ensure 24/7 on-site health personnel for delegate safety. In addition, the host region incident management



team and ambulances/ patient transport vehicles will also be available 24/7.

- b. The DepEd RO health team shall oversee the health and safety of their delegation, conduct health rounds, and promote positive health behavior.
- c. All technical personnel with comorbidities shall bring maintenance medication and disclose medical conditions to the delegation medical officer.
- d. Regional officials shall ensure the provision of nutritious and safe meals as per the menu approved by the regional Nutritionist-Dietitian, in accordance with DO 13, s. 2017 (Policy and Guidelines Healthy Food and Beverage Choices in Schools and in DepEd Office).
- e. Heat health measures (e.g. proper ventilation, access to drinking water/ hydration stations) shall be observed, especially from 10:00 AM to 3:00 PM.
- f. Daily medical case reporting shall be done by the DepEd RO health team using this link: <https://bit.ly/Paloro2026DailyRecord>.
- g. Health advisories (e.g., dengue, heat-related illnesses) shall be disseminated and may be accessed through this link: <https://tinyurl.com/PPHealthAdvisories2026>.
- h. Strict enforcement of No Smoking/No Vaping and No Alcohol policies shall be observed.

## 2. **Playing Venues**

The host region shall ensure the following for **each playing venue**:

- a. First aid station with hydration areas;
- b. No event shall begin without the presence of the designated LGU health team;
- c. Coordination between DepEd RO and LGU health personnel at first aid stations;
- d. Uniforms and IDs for all health personnel for easy identification;
- e. Sufficient number of LGU health personnel;
- f. Strategically positioned ambulances/ patient transport vehicles to respond to emergency and other related cases;
- g. To prevent heat-related illnesses, all outdoor games must be suspended between 10:00 AM and 3:00 PM. In the event that the reported and verified heat index reaches the danger zone (42°C-51°C and above), it is recommended that officials postpone all sporting events (indoor or outdoor) to protect the welfare of all learner-athletes and delegates.  
In addition, hydration stations must be visible and accessible to all delegates;
- h. Medical accompaniment for athletes in combative games;
- i. Ensure full compliance of learner-athletes with the medical requirements, especially for combative/ high-risk sports (boxing,

taekwondo, wrestling, pencak, wushu, gymnastics) and obtain final clearance before the actual sporting event, as determined by the designated Medical Officer/s;

- j. Strict enforcement of "Not Fit to Play" policy in the event of injury, illness or any health-related disruption during the conduct of the sporting event:
  - i. Any learner-athlete who sustains an injury or experiences a health-related concern shall be immediately assessed by the designated Medical Officer/s assigned at the playing venue.
  - ii. Learner-athletes assessed and declared "Not Fit to Play" shall be immediately withheld from further participation in the current sporting event they are participating in. Such medical determination shall be final and conclusive, and not subject to waiver, appeal or override by any non-medical personnel. Participation in other sporting event/s is subject to re-assessment of a designated medical officer.
- k. Strict enforcement of No Smoking/No Vaping and No Alcohol policies.

### 3. **Death Casualties**

In the event of a death, the host province shall assist with body transfer and provide PFA through trained guidance counselors or health personnel.

## **II. REPORTING TEMPLATES**

1. Submission of daily medical cases utilizing the official template provided through this link: <https://tinyurl.com/PPHealthFormsFolder2026>.
2. Each regional delegation shall assign a focal person to manage case reporting. Cut-off time: 10:00 PM.
3. Immediate reporting to the local incident management team (IMT) is required for the following:
  - . Sudden cardiac arrest;
  - a. Severe head or spinal injuries;
  - b. Mass casualty incidents;
  - c. Acute febrile illness of unknown origin;
  - d. Diarrheal or respiratory outbreaks (e.g., Influenza Like Illnesses/ ILIs, COVID-19);
  - e. Heatstroke or severe heat illness;
  - f. Meningitis or suspected vaccine-preventable diseases (e.g., measles, mumps);
  - g. Chemical/environmental hazards;
  - h. Suicide attempts or severe mental crises;
  - i. Animal bites.
4. Daily Consultation and Treatment Record





## VI. HOSPITALIZATION AND ARRANGEMENTS

The host region, in coordination with their partner hospitals, shall facilitate the following:

- a. Establish a *Palaro* Fast-Lane for prompt evaluation and management
- b. Identify dedicated rooms/wards for delegates requiring hospital admission
- c. Ensure 24/7 availability of ambulance and patient transport vehicle/s
- d. Ensure availability of medicines, medical supplies and other hospital services
- e. Provide zero balance billing mechanism for *Palaro* delegations

In addition, the following services shall be offered to *Palaro* delegations by the partner hospitals:

- a. Hospitalization Coverage
- b. Out-Patient Consultation
- c. Diagnostics (Laboratory Tests, Imaging Procedures such as CT scan, Ultrasound, Xray)
- d. Drugs, Medicines and Medical Supplies
- e. Referral Transportation
- f. Animal Bite Treatment

## VII. DEPLOYMENT PLAN

The host province shall provide health personnel and responders (nurses, doctors, search and rescue, and other volunteers) in coordination with their local incident management team/s on all areas (playing venues, billeting quarters, athletes dug-out) for the whole duration of the event, and will be available 24/7 to ensure health and welfare of delegation.

## **2026 PALARONG PAMBANSA GUIDELINES & PROTOCOLS (DISCIPLINARY)**

### **Background:**

The National Technical Working Group - Disciplinary Committee began in 2025 for the 65<sup>th</sup> *Palarong Pambansa* in Ilocos Norte. The main mandate is to strengthen the intervention and responsive mechanisms and consolidate all reported learner rights and protection (LRP) incidents by the designated Regional Learner Rights and Protection Desks situated in all regional billeting quarters and playing venues.

For this year's 66<sup>th</sup> *Palarong Pambansa*, scheduled to be held May 24-31, 2026, in the Province of Agusan del Sur, the Learner Rights and Protection Division (LRPD) has been tasked with once again establishing the NTWG for the Discipline Committee.

### **Objectives:**

In addition to strengthening the intervention and response mechanisms for addressing reported Learner Rights and Protection (LRP) concerns during national sporting events, the Discipline Committee (DC) shall review and validate reported incidents, conduct further investigation as may be necessary, and impose appropriate penalties or recommend corresponding actions. These functions shall cover reported cases of bullying, child abuse, misconduct, and unsportsmanlike behavior committed by learner participants and/or Department of Education (DepEd) teaching and non-teaching personnel, including coaches, trainers, and parents or guardians of learner participants.

The DC shall likewise complement the functions of the National and Regional LRP Desks by assisting in the consolidation, review, and processing of reported offenses identified in the succeeding items, particularly incidents directly reported to the Regional LRP Desk Officers.

### **Offenses Leading to Disciplinary Action:**

1. Violation of Section 15 of the DepEd Child Protection Policy<sup>1</sup>, specifically:
  - Child abuse
  - Discrimination against children
  - Child exploitation
  - Violence against children in school
  - Corporal punishment
  - Any act analogous or similar acts

2. Bullying as defined in the Revised Implementing Rules and Regulations (IRR) of RA 10627<sup>2</sup>, viz.

Section 4

e. **“Bullying”** refers to any severe, or repeated use by one or more learners of a written, verbal or electronic expression, or a physical act or gesture, or any combination thereof, directed at another learner that has the effect of actually causing or placing the latter in reasonable fear of physical or emotional harm or damage to his property; creating a hostile environment at school for the other student; infringing on the rights of another student at school; or materially and substantially disrupting the education process or the orderly operation of a school; such as, but not limited to, the following:

- i. **Physical Bullying** refers to any unwanted physical contact between the bully and the victim, like punching, pushing, shoving, kicking, slapping, tickling, headlocks, inflicting school pranks, teasing, fighting, and the use of available objects as weapons;
- ii. **Psychological or Emotional Bullying** refers to any act that causes damage to a victim’s psyche and/or emotional well-being;
- iii. **Verbal Bullying** refers to any slanderous statement or accusation that causes the victim undue emotional distress, like directing foul language or profanity at the target, name-calling, tormenting, and commenting negatively on victim’s looks, clothes and body;
- iv. **Cyber-bullying** refers to all forms of bullying, including online harassment, carried out through the use of technology or any electronic means such as, but not limited, to texting, email, instant messaging, chatting, trolling, spamming, posting hurtful comments, or posting of inappropriate photos and videos;
- v. **Social Bullying** refers to a form of bullying that aims to damage the social reputation of a learner or a group of learners, including but not limited to relationships affecting the victim’s social standing. Such acts include, but are not limited to, deliberate, repetitive, or aggressive social behavior against learners with disabilities, learners who are members of indigenous or ethno-linguistic groups, and learners who are part of religious groups, among others;
- vi. **Gender-based bullying** refers to any act that humiliates or excludes a person or targets individuals based on their gender or perceived gender identity and gender expression. It includes acts that create an intimidating, hostile, or humiliating environment for the victim, such as unwanted sexual remarks or actions, and the use of sexist, homophobic, misogynistic, or transphobic remarks, among others.

3. Misconduct<sup>3</sup> – encompassing a wide range of unethical and harmful behaviors, which may have been committed by any teaching or non-teaching personnel, coaches, or trainers, undermining fair play and the well-being of athletes:
  - a. Emotional Misconduct – both verbal and physical acts, ranging from name-calling to throwing equipment at an athlete. Stalking and withholding support can also be categorized as emotional misconduct.
  - b. Physical Misconduct – refers to any behavior that does or could lead to physical harm, including both contact and non-contact actions. Examples include punching, allowing athletes to return to play after an injury without medical clearance, and withholding food or water.
  - c. Sexual Misconduct – covers a broad spectrum of sexual actions performed without consent. This also includes grooming, sexual harassment, non-consensual sexual contact or intercourse, sexual exploitation, exposing a minor to sexual content or imagery, sexual bullying, and sexual hazing.
  - d. Harassment – refers to repeated or severe conduct that instills fear or humiliation, degrades an athlete, creates a hostile environment, or seeks to establish superiority based on an athlete's age, race, ethnicity, culture, religion, national origin, or disability.
  - e. Hazing – involves physical, mental, emotional, or psychological actions that could intimidate, degrade, abuse, or endanger an athlete for the sake of social acceptance. This could include behaviors such as forcing individuals to participate in drinking games, physically restraining them, or depriving them of water, food, or sleep.

### **Jurisdiction**

The DC shall exercise jurisdiction over the abovementioned offenses when committed while en route to, during, and after the *Palarong Pambansa*, provided that the learner is within the supervision, instruction, and custody of DepEd exercising special parental authority.<sup>4</sup>

### **Disciplinary Procedures**

#### **I. Filing of Complaint**

1. Any person may file a written or verbal complaint with the DC regarding a case of child abuse, bullying, and/or misconduct.
2. Any person who, acting in good faith, reports an incident of child abuse, bullying, and/or misconduct shall be free from any liability, and their anonymity assured. However, they must provide their names and contact details for further information, if necessary.
3. The person who reported in good faith must provide the basic information, such as name, age, region, the reason the learner is considered at risk for abuse/misconduct/bullying, and the alleged perpetrator.

4. Any person reporting the incident need not be the complainant but has sufficient knowledge of the incident involving possible child abuse, bullying, and/or misconduct.
5. The Regional LRP Desk Officers are mandated to report all incidents of possible child abuse, bullying, and/or misconduct that happened in their billeting quarters or were reported to them by any of the members of their delegation. The Report from the LRP Desk shall contain:
  - a. Detailed incident report
  - b. Immediate action/s taken, and
  - c. Intervention plan (Copy of the LRP Report is enclosed for reference)
6. The Discipline Committee may act on any report of child abuse, bullying, and/or misconduct regardless of whether a written report or complaint was made.

## **II. Investigation**

Upon receipt of the Complaint/Report, the Discipline Committee (DC) shall convene to determine whether there is substance in the allegation/s and whether the same falls within the scope of the DC's jurisdiction.

If the offense constitutes child abuse, bullying, and/or misconduct, the DC shall open a *pre-disciplinary file* containing the outline of the allegations and the immediate and appropriate interventions conducted.

The DC, with the assistance of the LRP Desk Officers, shall then investigate to collect further written evidence/s and written statement/s from all relevant witnesses for supporting evidence. An interview may be conducted with the complainant/s and alleged perpetrator/s, including the witnesses and interested party/ies.

Thereafter, the DC shall determine whether a *disciplinary case conference* will be conducted and the schedule thereof. A *notice* shall be issued to the complainant, including a copy of the allegations. The parties involved shall be informed of the conduct of the hearing and a reminder that non-attendance therewith will only be allowed under extenuating circumstances (i.e. sickness, threat of violence, and the like). Under such circumstances, a *written request* must be submitted to the DC.

## **III. Disciplinary Case Conference**

The Chairperson shall take charge of the *disciplinary case conference*. All witnesses or statement/s can be introduced at the hearing without the need for prior notice, and copies of all written evidence produced for consideration prior to the hearing.

However, the DC may adjourn the hearing to allow further evidence. After careful review of the statements and evidence presented, the DC shall now craft its Resolution and Recommendation, addressed to the *Palarong Pambansa Board*.

The DC, in the conduct of the *disciplinary case conference*, shall ensure the strict observance of the protocols as stated under the applicable DepEd issuances and related laws.

#### **IV. Recommendation for Disciplinary Action**

The DC shall inform the parties in writing of the Resolution and Recommendation and that the same has been endorsed to the *Palara* Board for appropriate action based on the applicable DepEd issuances and related laws.

#### **V. Appeal Process**

Parties may exercise their right to appeal the decision of the *Palara* Board, and the same may be addressed to the Board, a copy furnished to the DC.

The Discipline Committee may reconvene to deliberate on the motion and, thereafter, issue a resolution for the consideration of the *Palara* Board. In the conduct of its proceedings, the Department of Education's Revised Rules of Procedure in Administrative Cases may be applied in a suppletory manner.

### **Referral Mechanisms**

To strengthen our advocacy towards safe, enjoyable, and memorable Palara for all learner athletes, the Regional Office has partnered with the Provincial Government in deploying:

- o **Additional Registered Guidance Counselors (RGCs):** Providing Psychological First Aid (PFA) and immediate intervention.
- o **PGAS & MSWD Social Workers:** On-call for immediate protective custody or community-based support.
- o **PNP Women and Children Protection Center (WCPC):** Stationed nearby for rapid police response.
- o **Barangay Child Protection Unit:** to provide immediate assistance and community-based support for all delegates.

To ensure seamless coordination, the deployed LRP Desk Officers will observe the following:

- a. Synchronous Communication – real-time exchange of information through a dedicated radio frequency for the NTWG or Viber/Messenger Group, a directory will also be provided for easy communication for all LRP Desk Officers and for referral concerns.
- b. Reporting Link – where all reports may be submitted to the Disciplinary Committee for easy reference.
- c. Daily Huddle – 1-hour coordination meeting every evening to check on reports and deployment schedules.

Additionally, linkages have been established with the following agencies:

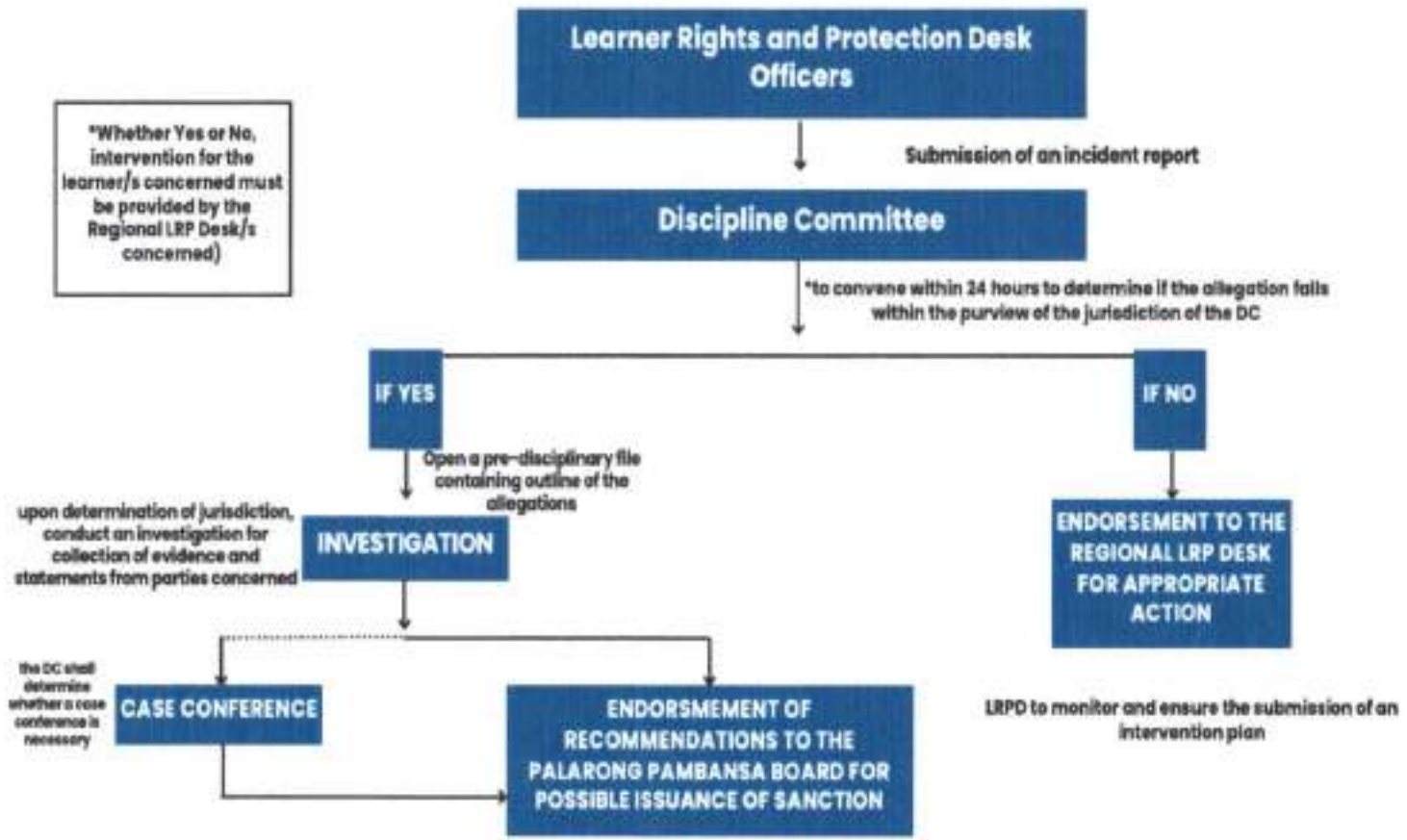
- Provincial Government of Agusan del Sur (PGAS) – provision of logistical support in cases of medical emergencies, etc.
- Philippine National Police – Women and Children Protection Desk
- Department of Social Welfare and Development (DSWD) – Local/Municipal Social Welfare and Development Office (L/MSWDO)
- Commission of Human Rights (CHR)
- Barangay Council for Child Protection

## 2026 Reforms

- LRPD Desk Officers, through our Guidance Counselors/Advocates, are mandated to implement **“positive interventions”** to support learner athletes in developing a corrective and reflective mindset. These efforts aim to help learner-athletes grow in discipline and uphold sportsmanlike conduct, and embody positive values both on and off the field.
- A dedicated LRP Desk officer will be assigned **to monitor the social media mentions** related to the 2026 *Palarong Pambansa*. The objective is to promptly identify and address potential cyberbullying incidents and/or other forms of abuse from further escalation.
- All assigned LRP Desk Officers are required to sign the Confidentiality Waiver to safeguard privacy and ensure that no information concerning learner-athletes or DepEd personnel involved is disclosed without proper authorization.

# REPORTING FLOW FOR REGIONAL LRP DESK OFFICERS

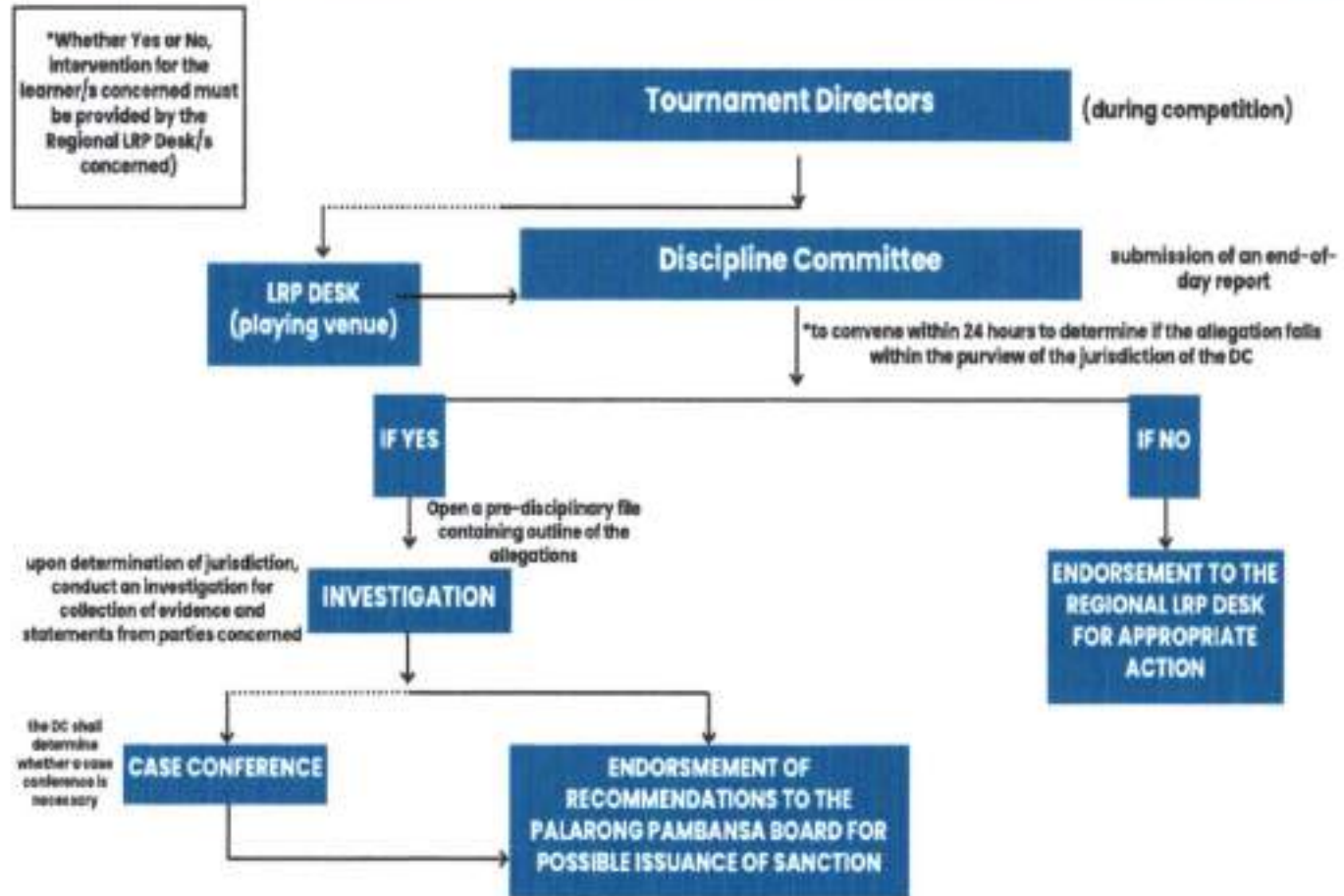
Reporting Mechanism:

## **2026 PALARONG PAMBANSA GUIDELINES & PROTOCOLS (JURY OF APPEALS)**

The Jury of Appeals shall ensure that all appeals filed shall be resolved fairly, expeditiously and in accordance with the set of established practices, protocols, rules and standards of a given sport event/discipline as well as those set for the Palaro in general.

### **I. GENERAL GUIDELINES**

- a. Only final decisions from tournament officials shall be appealable to the Jury of Appeals.
- b. All official appeals from decision of the tournament officials shall be filed with the Jury of Appeals within the time prescribed under the rules for each event/sport discipline.
- c. The appeal shall be deliberated upon by at least a majority of the Jury of Appeals present.
- d. The jury of appeals may call upon the parties, witnesses, or any expert to aid in their recommendation.
- e. After due deliberations, the jury of appeals, through its chairman, shall submit its recommendation for approval or disapproval of the Palarong Pambansa Secretary General.

### **II. PROTOCOLS**

- a. Members of the jury of appeals must demonstrate impartiality, professionalism, and confidentiality at all times.
- b. Any conflicts of interest must be disclosed immediately by any member.
- c. Non compliance with any requirement or process prior to appeal shall render the appeal dismissible.

### **III. ACTIVITIES OF THE JURY OF APPEALS**

- a. Provide the *Palarong Pambansa* Board with data collected on appeals filed and resolved as well as data on complaints/protests made relative to events/sports activity and provide appropriate policy recommendations or actions to be taken for improvement and to avoid protests or complaints.
- b. Provide technical assistance to any technical official on handling of controversies.
- c. Establish a centralized system for submission and consolidation of incident reports relative to protests for study and policy recommendation purposes.
- d. Maintain documentation and records of proceedings.

## **2026 PALARONG PAMBANSA KEY CHANGES IN THE TECHNICAL GUIDELINES (FOOTBALL) FOOTBALL SECONDARY BOYS/GIRLS, ELEMENTARY 8v8**

### **I. COMPETITION RULES AND REGULATIONS**

#### **A. General Rules**

Included is the **8-second Rule and 1 Captain Policy**.

#### **B. TECHNICAL PROCEDURE FOR FOOTBALL GIRLS SECONDARY 11 ASIDE WITH OFFSIDE**

Duration of match is **25 per half** with **10 minutes interval**.

#### **C. TECHNICAL PROCEDURE FOR 8v8 ELEMENTARY FOOTBALL**

1. Team Composition. Each team shall be composed of a maximum of 21 players, consisting of 18 players from the original school and 3 players from other schools (modified selection) and 2 officials, coach and an assistant coach. To ensure fairness and proper competition, each team must have at least a minimum of 16 players to qualify.
2. Allowable adjustments in Team Line-up, To accommodate varying team sizes, adjustments of team composition for this year PP are permitted within the approved player distributions. However, in the second year of implementation all teams from the lowest level of competition must have 21 players (18 core and 3 from Modified Selection) in the roster.
3. 21 Players – A team may register the full roster, with 10 players participating in the First Period, 11 players in the Second Period, and all 21 players eligible to play in the third Period.
4. 16 Players (Minimum) – A team may register the minimum requirement, with 8 players participating in the First Period, 8 players in the Second Period, and all 16 players eligible to play in the Final Third.
5. For odd number like 17 and 19 players in the team, the first period must be priority with full line up to 10 or 9
6. Team can play with minimum 7 players in first/second period only.
7. Two starting list will be submitted before the match for First and Second period and the Third starting list for Third period. This tasks belongs to the asst coach.
8. Match Periods and Player Participation
9. Each match shall be played in three (1st, 2nd & 3rd) periods, with each period lasting 15 minutes. Player rotation and participation will follow the standard team composition guidelines as detailed below: (for 21 players team composition)

10. First Third (15 minutes)
11. A total of 10 players will be fielded and includes 8 active players on the playing field and 2 substitute players.
12. The line-up must follow the standard team composition requirements.
13. Second Third (15 minutes). Another set of 11 players will participate.
14. Again, this includes 8 active players on the playing field and 3 substitute players.
15. This ensures that a different group of players is given playing time. The team must bring 2 sets of colored vests to distinguished players for 2nd Period. Substitution is after the 5th minute mark and will be informed by 4th officials as well as the last 2 minutes as a reminder. Decision about the substitute player lies on the coach as long as it does not delay the game flow.
16. Final Third (15 minutes). All 21 registered players are allowed to take part in this final phase.
17. Player rotation and substitution may be applied as necessary, while still following the standard team composition rule. (3 Opportunities/Concussion/ replacement substitution is applied).
18. If an injury happened with in the 5th minute mark, player can be replaced only after the fifth minute mark.

#### **Kick-Off Procedure**

19. The referee tosses a coin, and the team that wins the toss decides field or ball.
20. For the second period, the teams change ends and attack the opposite goals
21. For final period, The referee tosses a coin again, and the team that wins the toss decides field or ball

#### **Break Time**

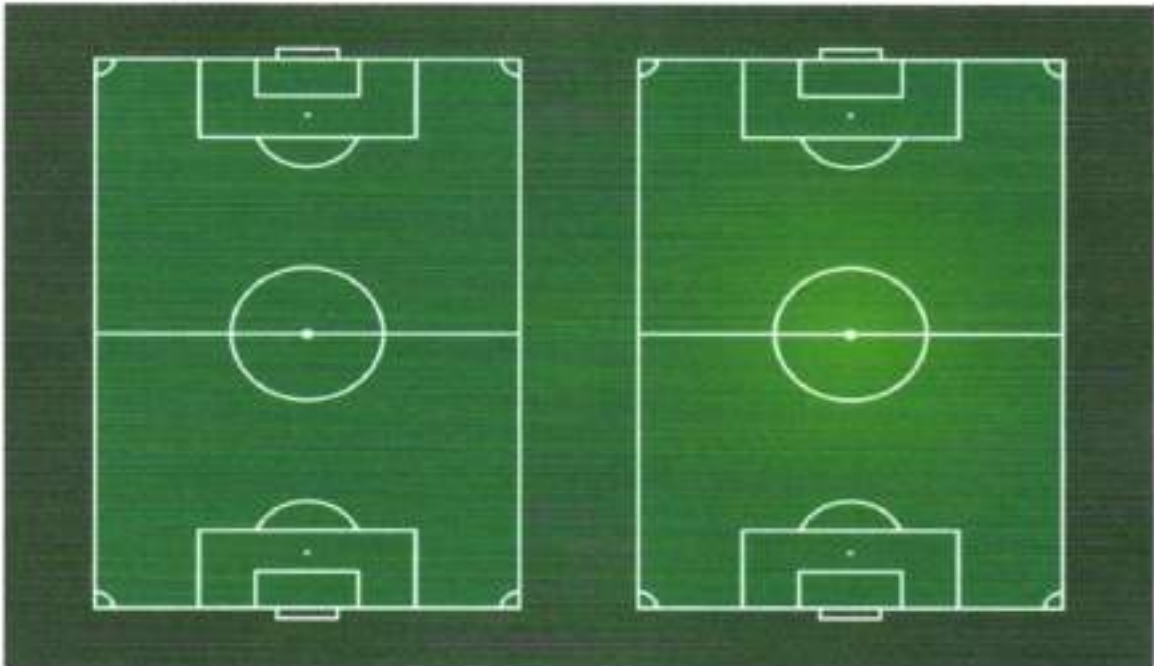
22. A 5-minute official break shall be implemented between period. This ensures that players have sufficient rest and preparation before entering the Final Third, where all players may participate.
23. Unless the weather is very hot at 8 minutes each period team can take 1 minute water break/ if necessary (very hot) 2 water breaks (3 minutes) at 5 minutes interval.

#### **Sin Bin**

24. Players who received cautionable offense due to reckless challenge only is suspended by 3 minutes through the Sin Bin. The Sin Bin Area is beside the fourth Official/secretariat where the caution player will stay after receiving YC. The player stay is for 3 minutes, after three minutes fourth official/ secretariat will approach 1st asst referee and recommend player to enter the field of play. Referee will allow player to enter how ever, as long he does not interfere with play, the asst referee may allow player to enter whether in stoppage or active play.
