# REITERATION OF THE "NO COLLECTION POLICY" ON DEPED TEXTBOOKS (TXS) AND TEACHERS MANUALS (TMS)

## To Schools Division Superintendents

- 1. In support of the Department of Education's commitment to uphold access to free quality education, this Office reiterates the strict implementation of the "No Collection Policy" regarding the distribution and use of DepEd-provided Textbooks (TXs) and Teachers' Manuals (TMs). These materials are government property and are provided free of charge to all learners and teachers in public schools. No amount or fee, in any form, should be solicited or collected in exchange for these instructional materials.
- 2. The Procurement of the Development, Printing, and Delivery of Textbooks and Teachers' Manuals, along with the Provision of Electronic Textbooks and Teacher's Manuals for Grades 4, 7, and Senior High School (SHS) was facilitated by the DepEd-Bureau of Learning Resources (BLR). These learning resources have been centrally funded and distributed by the Department and therefore must not be subject to any form of payment, contribution, or collection from parents, guardians, or learners.
- 3. Schools Division Offices are directed to instruct all School Heads to communicate the "No Collection Policy" clearly to teachers, parents, and other stakeholders. Any report or practice of collecting payments or contributions for DepEd-provided textbooks and teachers' manuals must be immediately addressed and reported to the appropriate authorities for necessary action. Furthermore, SDOs are likewise enjoined to closely monitor the implementation of this policy and ensure that no learner or teacher is denied access to learning resources due to unauthorized collections.
- 4. For guidance, immediate compliance, and widest dissemination.
