SUBJECT : DEPARTMENT OF EDUCATION RECOMMENDATION FOR APPROVAL OF PILOT FACE-TO-FACE CLASSES IN 120 SCHOOLS

Please be informed that the President has **approved** the recommendation of the DepEd in its Memorandum dated 10 September 2021 to allow the conduct of pilot face-to-face classes for a period of two (2) months in 100 public and 20 private schools in areas with minimal COVID-19 risk.

The DepEd is instructed to ensure that such pilot implementation will be consistent with the public health standards imposed by the IATF, the Department of Health, and relevant laws, rules and regulations.

The expansion of such face-to-face classes, if warranted by the results of the pilot implementation, shall be subject to the approval of the President.
