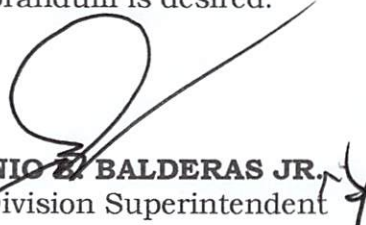

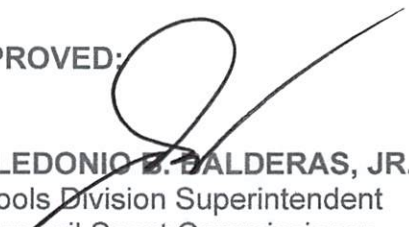

2. **QUALIFICATION:**
