## ORAL HEALTH PROGRAM FOR THE HEALTH AND WELNESS OF SDO PERSONNEL

To: OIC-Assistant Schools Division Superintendent Chief Education Supervisors Heads, Unit/Section All Others Concerned

1. Pursuant to DO. No 041 s.2020- Guidelines on the Implementation of School Dental Health Care Program, including Medical and Nursing Services For School Year 2020-2021, this activity aims to ensure the maintenance of good oral health through an institutionalized holistic approach in the prevention and treatment of oral diseases as part of the Wellness and Health Advocacy Program of the School Health and Nutrition Section.

2. The Health and Nutrition Section – Dental, will be providing basic dental services limited to dental check-up, oral urgent treatment and topical fluoride application to SDO Personnel at the Kalumpang Elementary School SDHCP Clinic from October to December 2021. The list of personnel are selected in the order of priority of oral needs based on the online oral health status monitoring form.

3. All personnel who will undergo dental procedures on the scheduled date are advised to follow strict compliance to the minimum public health standards and perform the following protocols:

- a. Temperature check and sanitizing hands upon entry
- b. Properly filled up Health Declaration Survey and Dental Consent Form upon entry: bring your own pen
- c. Wearing Face mask and face shield
- d. Observe physical distancing

4. Attached is Enclosure 1 - List of personnel and the corresponding schedule of dental appointment. All personnel in the list who are willing to have a dental appointment with the Dentist II are highly encouraged to comply with the schedule provided. If a personnel wish to decline the scheduled appointment, the Dentist II must be informed at least a week before the designated date.
