REITERATION ON STRENGTHENING THE SCHOOL GOVERNANCE COUNCIL (SGC) FOR SY 2025-2026

To: Assistant Schools Division Superintendent Chief Education Program Supervisors Heads, Public Elementary and Secondary Schools Heads, Unit/Section All Others Concerned

- 1. Relative to **DepEd Order No. 26, s. 2022**, titled **Implementing Guidelines on the Establishment of School Governance Council** which mandates all public schools to establish their respective SGCs to strengthen the role of school stakeholders as partners in providing learners accessible and quality education upholding children's rights and promoting respect and well-being in the learning environment to ensure effective education service delivery, this Office reminds all School Heads to strengthen the implementation of SGC.
- 2. To strengthen the implementation of SGCs, the Bureau of Human Resource and Organization Development–School Effectiveness Division (BHROD-SED) has developed the **SGC To-Do Calendar**. This tool serves as a practical guide for building and sustaining a functional SGC. It helps councils stay organized, aligned with the school's goals, and focused on continuous improvement.
