This activity aims to gather data on the implementation of the Alternative Learning System (ALS) Program; assess the effectiveness and efficiency of the field implementers in implementing the policies, programs, and projects towards the realization of ALS targets and DepEd standards; and recognize issues and concerns for appropriate interventions and/or technical assistance.
3. All members of the ALS Division Monitoring Team **shall conduct at least two (2) Monitoring Activities every month to each ALS teacher** and submit the following:
 - a. Written Monitoring and Evaluation Report
 - b. Copy of filled-out Monitoring Templates
 - c. MOVs
4. Travel and other related expenses of the Division Monitoring Team relative to the conduct of the activity will be charged against MOOE or local fund subject to usual accounting and auditing rules and regulations.

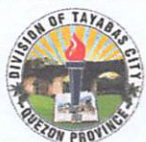
