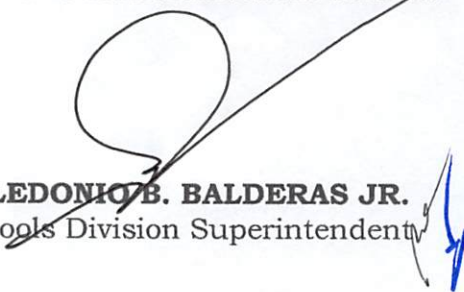

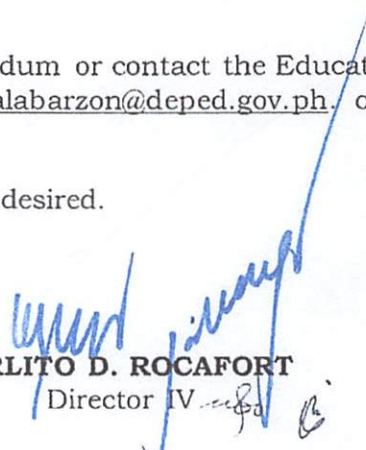

DATE : 15 JULY 2026

The Department of Education (DepEd) recognizes sports as a vital educational platform that contributes to the holistic development of learners by fostering physical fitness, discipline, teamwork, leadership, resilience, sportsmanship, and excellence. Consistent with its commitment to nurturing well-rounded and values-driven learners, the Department continues to implement the provisions of Republic Act No. 10588, otherwise known as the *Palarong Pambansa* Act of 2013, and the corresponding policy updates provided under the DepEd Memorandum OM-OUGOPS-2026-05-08594.

Pursuant to these policies, the National Screening and Accreditation Committee (NSAC) is entrusted with the responsibility of ensuring proper screening and accreditation of athletes, coaches, assistant coaches, and chaperones who will participate in the *Palarong Pambansa*. This includes verifying compliance with eligibility requirements, evaluating documentary submissions, and facilitating the timely submission of the official roster of qualified delegates to the *Palarong Pambansa* Board.

As the highest national sporting event competition for basic education learners, the *Palarong Pambansa* requires a screening and accreditation system that is transparent, efficient, reliable, and aligned with established standards and regulations. Upholding the integrity of the games requires competent and well-

equipped screening and accreditation personnel who possess a comprehensive understanding of applicable policies, procedures, and accreditation protocols.

To ensure the consistent and effective implementation of the screening and accreditation process across all regions, the Department shall conduct the **National Training on the 2027 Palarong Pambansa Screening and Accreditation Process** intended for the National Screening and Accreditation Committee (NSAC), Regional Screening and Accreditation Committee (RSAC) Chairman, Division Screening and Accreditation Committee (DSAC) Chairman, Regional Sports Officers (RSOs) and the National Academy of Sports (NAS) on **August 24-27, 2026** at the **Baguio Teachers Camp, Baguio City**. The training aims to strengthen the technical knowledge and understanding of eligibility requirements, documentary standards, accreditation procedures, and other relevant policies governing participation in the *Palarong Pambansa*.

Through this activity, the Department seeks to promote a standardized, transparent, and accountable accreditation process that ensures the participation of only duly qualified and eligible delegates. Ultimately, this initiative reinforces the credibility, integrity, and excellence of the *Palarong Pambansa* while supporting the Department's commitment to fair play, good governance, and the effective implementation of school sports programs nationwide.

Expenses related to the conduct of the training, including those incurred *Palarong Pambansa* Secretariat and members of the National Screening and Accreditation Committee (NSAC), shall be charged against the 2026 Physical Fitness and School Sports (PFSS) Funds, while expenses of all other participants shall be charged against their local funds, subject to the existing government accounting and auditing rules and regulations.
