**CONDUCT OF PSYCHO-EDUCATIONAL ASSESSMENT FOR LEARNERS WITH  
DISABILITIES (LWDs)**

1. In adherence to DepEd Order No. 44, s. 2021, re: Policy Guidelines on the Provision of Educational Program and Services for Learners with Disabilities in the K to 12 Basic Education Program, this Office informs all concerned that the conduct of Psychoeducational Assessment of Learners with Disabilities (LWDs) will be administered by Developmental Psychologists this month of September 2022. This is in partnership with Disability Affairs Unit of the City Social Welfare and Development Office.
2. The activity aims to continually monitor the LWDs progress in all domains of development, namely the cognitive, socio-emotional, physical, motor, and moral-spiritual domain and to clearly establish the goals for LWD's learning and development areas needed in crafting the learner's IEP.
3. Prior to the conduct of psychoeducational assessment, receiving and SPED teachers of Batch 1 identified LWDs will conduct an initial assessment, using the Developmental Checklist.
