

Category: **IMPROPTU SPEECH (DAGLIANG TALUMPATI)**

Guidelines and Mechanics:

1. The contest is open to all Senior High School learners enrolled in private and public schools.
2. There shall be 1 learner-participant only per school.
3. Proctor shall confirm the participants based on the pre-registration.
4. The competition shall use Filipino as primary language; however participant may incorporate English terms or phrases when citing sources, quotation, or emphasizing key ideas to support their claims and arguments.
5. Each participant shall draw a topic, prepared by the TWG. The proctor shall read aloud the topic twice.
6. Each learner participant shall be given 2mins preparation and shall deliver his/her speech in 5 minutes.
7. The speech must be original, spontaneous, clear and emotionally engaging.
8. The decision of the board of judges is final.

Guidelines and Mechanics:

1. The contest is open to all Grade 6 learners enrolled in private and public schools.
2. Proctor shall confirm the participants based on the pre-registration.
3. Each participant shall create a poster aligned with the theme of **Linggo ng Kabataan “Local Youth Action for Sustainable Development Goals and Beyond”**.
4. All schools are allowed only 1 entry.
5. Participants are expected to bring their own materials.
6. The decision of the board of judges is final.

Category: **QUIZ BEE**

Quiz Bee - Manuel Luis Quezon
Tayabas City

Round	Presentation (point/s per item)
Easy (10 items)	1 (10 points)
Average (10 items)	2 (20 points)
Difficult (10 items)	3 (30 points)
Total = 30 items	Total = 60 points

Mechanics:

- a. The quiz is open to all **Grade 8 learners** who are officially enrolled in Tayabas City (public and private schools)
- b. There shall be 1 learner-participant only per school.
- c. The questions shall be provided by the Department of Education – SDO Tayabas City with reference for each item.
- d. During the quiz, learner-contestants shall be provided with 1/8 illustration board, chalks and erasers (to be provided by LGU).
- e. Filipino shall be used as the official language in the conduct of the quiz.
- f. Contestants shall be given a total of 30 questions: 10 questions for each round.
- g. For easy round, the questions shall be multiple choice items. For the average and difficult rounds, there shall be no options to choose from.
- h. Contestants shall be given ten (10) seconds for easy, twelve (12) seconds for average, and fifteen (15) seconds for difficult round to answer the question.
- i. The quizmaster shall read each question twice. Countdown shall start after the question has been read the second time and the quizmaster says “GO”. When the quizmaster says “STOP” or “TIME IS UP”, contestants must raise their answers to the audience and to the Board of Judges until such time that the proctors have verified or confirmed the answer. Those who are unable to observe the instruction shall not earn a point. The Chair of the Board of Judges will decide whether or not the instruction is observed.
- j. Contestants are allowed to change their answer within the allotted time.
- k. In case of a protest or inquiry during the actual quiz proceedings, the following procedures shall be observed:
 - Only the contestants or the official coaches are allowed to raise a protest or inquiry before the next question is read.
 - The protest or inquiry shall be addressed orally to the chair of the board of judges who shall recognize the protest or inquiry after validating the proof / evidence presented.
 - The chair shall announce the decision upon deliberation with the members of the board of judges.
1. The decision of the Board of Judges is final.
