#### RESUMPTION OF HEALTH INSPECTION OF LEARNERS AND CLINIC DUTIES IN SCHOOLS FOR SY 2024-2025

To: Assistant Schools Division Superintendent Chief Education Supervisors Heads, Public Elementary and Secondary Schools Heads, Units/Sections All Others Concerned

1. Health Inspection of Learners falls under the Department of Education's (DepEd) initiatives to promote health and wellness among learners. The DepEd Order No. 28, s. 2019 outlined the Policy and Guidelines on Oplan Kalusugan sa DepEd (Ok sa DepEd). The said issuance consolidates all the health and nutrition programs to be implemented which includes health inspection of learners under the Medical, Dental, and Nursing Services.

2. In line with this, the School Health and Nutrition Unit will resume going to our schools to conduct periodic health and dental examination of learners, to give technical assistance on Ok sa DepEd program, and to monitor and evaluate the implementation of Ok sa DepEd and other health-related programs. In addition, the members of the team will have a separate schedule on Clinic Duties in Tayabas East Central School (TECS), Kalumpang Elementary School (KES), and Luis Palad Integrated High School (LPIHS).

3. Please see attached proposed schedule of the School Health and Nutrition Team. The schedule can be subject to changes depending on the exigency of service.
