### CORRIGENDUM TO DM NO. 523 S. 2024 RE: SCHEDULE OF DEWORMING 2024

To: Assistant Schools Division Superintendent Chief Education Supervisors Heads, Public Elementary and Secondary Schools Heads, Unit/Section All Others Concerned

1. Relative to **DepEd Order No. 9, s. 2024**, this Office through the Education Support Services Division - School Health and Nutrition Unit announces the Deworming Schedule for 2024 onwards.

2. As stipulated in **DepEd Memorandum 22-199**, titled **2021 Deworming Accomplishment**, the following are reiterated:

a. Schools with face-to-face classes should conduct deworming;

b. For those who are on modular and/ or online learning, deworming tablets can be distributed with the modules or on an agreed date and means of verification secured after proper orientation of parent/guardian;

c. Exhaust all means to ensure that the target learners are dewormed and are properly reported; and

d. Deworming drugs and paraphernalia procurement is devolved to the Local Government Unit since 2023. Intensification of LGU coordination through the Local Health Board should be made.
