    - iv. The impact and outcomes of the implemented activities

4. Technical and Audio Quality	<ul> <li>Adheres to video format (MP4), duration (maximum of 3 minutes), and resolution (at least 1080p), video is in landscape orientation.</li> <li>Voice-over or narration is clear; background music enhances rather than distracts.</li> </ul>	15
