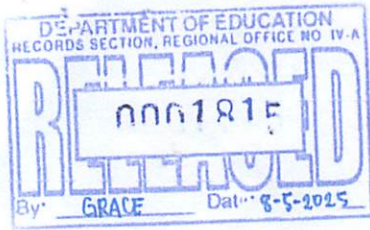

To **Schools Division Superintendents**

1. Pursuant to RA 11650, also known as "An Act Instituting a Policy of Inclusion and Services for Learners with Disabilities in Support of Inclusive Education" and in support to the MATATAG Agenda, this Office will conduct the **Regional Training on School Personnel on SNED Individualized Education Plan (IEP) and creation of school-based Multidisciplinary Team (MDT)-Batches 1-3** on dates listed below.
