CONDUCT OF PSYCHO-EDUCATIONAL ASSESSMENT FOR LEARNERS WITH DISABILITIES (LWDs)

To: Assistant Schools Division Superintendent Chief Education Supervisors Heads, Public Elementary and Secondary Schools Heads, Unit/Section

- 1. In adherence to **DepEd Order No. 44, s. 2021**, titled "Policy Guidelines on the Provision of Educational Program and Services for Learners with Disabilities in the K to 12 Basic Education Program," this Office hereby informs all concerned that the Psychoeducational and Developmental Assessment for Learners with Disabilities/Difficulties (LWDs) shall be administered by the Educational Psychologists on **September 11–12, 2025**, from **8:00 a.m. to 4:00 p.m.** at the **TECS SNED Resource Room**.
- 2. The primary objective of this activity is to generate comprehensive information and data that will establish the learner's current level of functioning across key domains—cognitive, motor, psychosocial, communication, and adaptive skills. These findings will serve as the basis for setting clear and realistic goals in the learner's developmental and learning areas, which are essential in the formulation of an appropriate and responsive Individualized Education Plan (IEP) for each LWD.
- 3. Concerned school heads and teachers are directed to ensure the attendance of identified learners and provide the necessary support to facilitate the smooth conduct of the activity.
- 4. Attached is the Psycho-educational Assessment schedule.
