# CONTINUING IMPLEMENTATION OF DRRM AND EMERGENCY PREPAREDNESS MEASURES IN ALL DEPED SCHOOLS

- 1. In reference to **Republic Act 10121** titled **Philippine Disaster Risk Reduction Management Act of 2010** and in view of the recent earthquake incidents in various parts of the country and the ongoing threats posed by natural hazards, this Office respectfully reminds and encourages the continued implementation and strengthening of emergency preparedness and Disaster Risk Reduction and Management (DRRM) measures in all public schools within the Division of Tayabas City.
- 2. As part of the school preparedness, schools are expected to undertake relevant activities which emphasize Disaster Risk Reduction and Management (DRRM) education focusing of natural hazards, such as, but not limited to the following:
  - a. Announced and unannounced Earthquake Drills
  - b. Presence of Standardized School DRRM Team in conspicuous places;
  - c. Posting of emergency numbers and hotlines:
  - d. Label and number all school buildings;
  - e. Provide a directory or location map in conspicuous places;
  - f. Post IEC (infographics) materials around school premises;
  - g. Installation of appropriate signage inside and outside school premises;
  - h. Devote time to class discussion on preparedness, mitigation, and prevention before, during and after earthquake;
  - i. Conduct of Symposium or Forum on DRRM in coordination with LGU, NGAs and NGOs;
  - Conduct of related activities to ensure heightened awareness, consciousness, and mitigation among school administrators, teachers, personnel, parents, and school children.
