- 1. In reference to DepEd Office of the Undersecretary for Learning Systems Memorandum DM-LS-2025-090 titled ONLINE FOLLOW THROUGH AND MENTORING SESSIONS FOR THE SPECIAL PROGRAM IN FOREIGN LANGUAGE (SPFL) CHINESE TEACHES, this Office, through the Curriculum and Learning Management Division (CLMD) and DepEd CALABARZON field personnel, shall participate in the said activity, organized by the Confucius Institute at the Angeles University Foundation (CI-AUF) from October 04, 2025 to March 21, 2026 (two hours every Saturday) via an online platform.

In addition, recognizing the efforts of the participating teachers, they are eligible to avail service credits commensurate to the number of hours/ days of the training as scheduled, pursuant to DepEd Order No. 13, s. 2024 titled Revised *Guidelines on the Grant of Vacant Service Credits for Teachers*.
