# DIVISION ORIENTATION ON THE ADMINISTRATION AND UTILIZATION OF THE RAPID MATHEMATICS ASSESSMENT: DEVELOPMENT OF INTERVENTION AND ENRICHMENT MATERIALS

To: Assistant Schools Division Superintendent Chief Education Supervisors Heads, Public Secondary Schools Heads, Unit/Section All Others Concerned

- 1. Pursuant to Unnumbered Joint Memorandum entitled 2024 Implementing Guidelines of the Program Support Fund for the Administration of the Rapid Mathematics Assessment (RMA) and Printing of RMA Tools and Mathematics Supplementary Learning Materials dated 18 November 2024 and DepEd Order No. 13, s. 2023 National Learning Recovery Program (NLRP), this Office, through the Curriculum Implementation Division, will conduct the Division Orientation on the Administration and Utilization of the Rapid Mathematics Assessment: Development of Intervention and Enrichment Materials at Tagaytay Country Hotel, Tagaytay City on 06 08 November 2025.
- 2. This activity aims to strengthen numeracy instruction and intervention through effective use of the **Rapid Mathematics Assessment (RMA)** results. Specifically, the activities seek to:
  - a. Orient participants on the objectives, structure, and administration protocols of the RMA tool to ensure accuracy, consistency, and fidelity in its implementation across schools;
  - b. Equip teachers and school leaders with the skills to interpret RMA results and use data for informed decision-making in designing classroom and school-based interventions;
  - c. **Develop, validate, and produce learning resources** that address numeracy gaps in foundational skills such as the four basic operations, fractions, decimals, and percentages;
  - d. Provide enrichment opportunities for learners demonstrating higher proficiency levels to foster continuous growth, motivation, and mathematical excellence;
  - e. Capacitate teachers in the use of the HOTS-SOLO framework to enhance classroom instruction, develop higher-order thinking skills among learners, and improve assessment practices in mathematics; and
  - f. Promote data-driven planning and continuous improvement in numeracy programs across schools to ensure sustainability and measurable learner progress.

- 3. Participants in this activity are teachers from public elementary and secondary schools who are advised to bring a laptop and an extension cord (See Enclosure 1).
