REGISTRATION OF THE REGULAR PHILIPPINE EDUCATIONAL PLACEMENT TEST

To: Assistant Schools Division Superintendent
Chief Education Supervisors
Heads, Public and Private Elementary Schools
Heads, Unit/Section
All Others Concerned

- 1. Pursuant to **DepEd Order No. 055**, **s. 2016** titled Policy Guidelines on the on the National Assessment of Student Learning for K to 12 Basic Education Program and **DepEd Memorandum No. 098 s. 2025** titled Administration of the Regular Philippine Educational Placement Test (PEPT), the City Schools Division of the City of Tayabas will conduct the registration on **November 5**, **2025 until the week before the test administration**.
- 2. This activity aims to administer assessment for learners in special circumstances.
- Target registrants for PEPT are the following:
 - a. Learners from schools without government permits.
 - b. Learners from non-formal and informal education programs.
 - c. Learners who have incomplete or no record of formal schooling.
 - d. Learners with back subjects.
 - e. Learners who need grade level standards assessments.
 - f. Learners who are overage for their grade levels.
- 4. Pursuant to Section 6 (Grade Level Placement Assessment) of **DepEd Order No. 55 s. 2016**, the placement of the Regular PEPT qualifiers shall take effect in the next school year, not during the current school year when the test was administered.
- No test registration fees shall be collected from the test registrants.
- 6. **No walk-in policy** shall be strictly implemented on the day of test administration to ensure test security, accurate evaluation, completeness of documentary requirements and orderly flow of services.

- 8. Below are the requirements for the specific types of test registrants:
 - a. For New Test Takers

- i. Original and one photocopy of the **birth certificate** duly authenticated and issued by the Philippine Statistics Authority (PSA) formerly National Statistics Office or the Local Civil Registrar.
- ii. **Certified True Copy of the permanent record** (e.g., SF10/ Form 137) signed by the school principal / registrar/school administrator with dry seal.
- iii. **Certificate of Attendance in intervention programs**, or any proof of school (if applicable).
- iv. Two identical and recently taken 1x1 colored ID pictures with name tags.
- v. One copy of the accomplished Regular PEPT Registration Form.

b. For test retakers and PEPT passers

- i. Original and one photocopy of the PEPT Certificate of Rating.
- ii. Two identical and recently taken 1x1 colored ID pictures with name tags.
- iii. One copy of the accomplished Regular PEPT Registration Form.
- 9. Registration is on **first come**, **first serve basis only** due to limited allocation.
- 10. Expenses incurred during the orientation and administration of Regular PEPT shall be charged against existing available local funds subject to the usual accounting and auditing rules and regulations.
