In preparation for the conduct of the **Psychoeducational Assessment** funded by the Local Government Unit through the City Social Welfare and Development Office (CSWDO), all concerned schools are hereby directed to ensure the complete submission of the required documents of identified learners on or before **February 27, 2026**.

- b. Certificate of Indigency
- c. Birth Certificate or Valid ID of the learner/child
- d. Recommendation from teacher
- e. Cedula (Community Tax Certificate) 2026
- f. COMELEC Certification of Voter's ID (parent)
- g. PWD ID (if applicable)
- h. General Intake Sheet (Enclosure 1)

3. All documents shall be submitted to the Persons with Disability Affairs Office (PDAO) through **Ms. Lilibeth C. Tadosa**. Processing and assessment slots will be **accommodated on a first come, first served basis**.

4. School Heads are instructed to ensure the timely collection and submission of the above documents to facilitate smooth processing and scheduling of the assessment.
