 - b. Original copy of owners duplicate of TCT/OCT;
 - c. Copy of approved survey plan;
 - d. Certified true copy of Tax Declaration;
 - e. Certificate of No Tax Delinquency;
 - f. Transfer Tax;
 - g. BIR Clearance;
 - h. DAR Clearance (if agricultural/camotal land)
- 3. Prepare a summary of all the documents on record for identification and validation of donated schools that will qualify for titling.

- 4. Once existing school sites are identified and validated, request for funds for the titling of identified sites together with supporting documents shall be submitted to Sites Titling Office coursed through this Office.
- Submit to this Office (Attention: Legal Unit) monthly consolidated report of special Patents registered and issued by your respective Local Registry of Deeds every last Monday of the month starting January, 2017.
