Date: January 31, 2018

- Pursuant to DepEd Memorandum No. 003, s. 2018, re: 2018 Metrobank Foundation Outstanding Filipinos-Award for Teachers, all schools are encouraged to submit nominees for Outstanding Filipinos-Award for Teachers.
- 2. This award aims to recognize outstanding Filipinos who are responsible citizens, exemplary public servants, and agents of positive change in their respective communities.
- 3. Elementary school heads are entitled to nominate two teachers: (one for primary (Kindergarten to Grade 3) and another for intermediate (Grades 4 to 6) level, while high school heads are entitled to nominate only one teacher.
- 4. Criteria for the nominees:
  - a. Nominees must have been actively teaching for the last ten years (inclusive of leaves not exceeding three years, provided that the nominee is teaching at the time of nomination). Teachers who are on official or sabbatical leave during the time of nomination are still qualified; however, they must still have at least three remaining years of service before retirement.
  - b. Nominees must have at least completed academic requirement for Master's degree for both elementary and secondary categories.
  - c. Nominees must have average performance ratings of at least **Very Satisfactory** for the past ten years in teaching. For those who have been on official/study leave or on secondment, performance ratings for ten years closest to the period of nomination should be provided.

- d. Nominees must NOT have been adjudged guilty in any administrative, civil or criminal case.
- e. Nominees for the elementary and secondary categories must have valid license as a teacher from the Professional Regulation Commission.
- 5. Winners of other local awards for outstanding teachers are encouraged to join, provided the eligibility requirements are met.
- 6. Submission of nomination is on February 7, 2018 at the Office of the Assistant Schools Division Superintendent.
