- In its effort to upgrade the coaching competencies of the coaches, the Department of Education (DepEd) through the Bureau of Learner Support Services - School Sports Division (BLSS - SSD) shall conduct the National Training on Sports Coaching (Advanced Level) Clusters 1 and 2 in Palmas del Mar Hotel, Bacolod City on October 21-25, 2019 and in Marizon Hotel, Kalibo, Aklan on November 4-8, 2019, respectively.
- 2. The advanced level is designed for coaches in advanced level of competition and teach the sport for optimum performance. This will cover match analysis, psychological aspects of coaching and designing training programs.
- 3. A total of four hundred fifty-eight (458) participants for cluster 1 and three hundred nine (309) participants for cluster 2. Participants to the advanced level are those who passed the intermediate level held in Pangasinan 2017 and Palawan 2018. Attached is the list of qualified participants per region.
