**2017 DIVISION JAZZ CLINIQUE SERIES FOR CAMPUS JOURNALISTS
AND SCHOOL PAPER ADVISER - CONTESTANTS**

1. Pursuant to the provision of Campus Journalism Act of 1991 (RA 7079), the City Schools Division of Tayabas will conduct the 2017 Division Cliniquing Series for Campus Journalists and School Paper Adviser-Contestants on October 26-27, 2017 (Series 1) and November 8-10, 2017 (Series 2) tentatively at Luis Palad Integrated High School and Tayabas East Central School respectively.
2. This training aims to enhance the journalistic competence of the DSPC Winning Campus Journalists and School Paper Adviser-Contestants. Other participants are DACATA Officers and selected Teachers and Journalism Coaches to act as Speaker-Trainer/ Facilitators and members of the TWG.
3. Photojournalists are advised to bring digital camera (point and shoot only) with a maximum of 20 megapixels. Any DSLR and other high-end camera are allowed only for this training and **NOT** during the RSPC. For cartoonists, Mongol 2 Pencil is advised. Participants in Group Categories should bring their own laptop, extension wires, pocket wifi and printer.
4. All winning School Paper Advisers should also bring LCD projectors for the activity.
5. There will be **NO** registration fee to be collected. Food, transportation and other expenses of participants relative to the conduct of this activity shall be charged to the Campus Publication Fund/ School Fund.
6. Attached are the List of DSPC Winners, School Paper Adviser-Contestants, TWG and Training Matrix.
7. This activity shall be subject to the no-disruption-of-classes policy stipulated in DepEd Order No. 9, s. 2015 entitled *Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith*.
