1. Pursuant to DepEd Order No. 54 s. 2009 entitled "Revised Guidelines Governing Parents-Teachers Associations at the School Levels and DepEd Order No. 77 s. 2009 known as "The Guidelines of Elections of the Parents-Teachers Association at the School Levels and Federation, all schools in this Division of are expected to observe the following schedule of activities:

- a. Organization of Homeroom PTAs and election of officers shall be held fifteen (15) days from the start of the school year;
- b. Election of the Board of Directors (BOD) of the school PTA shall be held within thirty (30) days from the start of the school year;
- c. Election of Officers of the school PTA shall be on the same day of their election on the BOD;
- d. Election of the Officers of the City PTA Federation shall be held within forty-five (45) days from the start of the school year;

2. All school heads are directed to create and convene six (6) members of the Election Committee (ELECOM) composed of two (2) teachers (one of whom shall be the chairperson and the latter shall vote only in case of a tie) and four (4) parent-members. They shall facilitate the conduct of the Homeroom and School PTA elections.

3. Accomplishment report regarding Homeroom PTA Election, Board of Directors and school PTA is on July 20, 2019 at the SGOD Office.

4. Submission of Annual Financial Statement signed jointly by the PTA president, treasurer and auditor is a requirement prior the conduct of provision 1a. Thus, Certificate of
