DIVISION GUIDELINES ON THE SEARCH FOR OUTSTANDING LEARNER IN DRUG ABUSE PREVENTION ADVOCACY

- 1. Must be a Learner from Public Secondary Schools in the City of Tayabas. (Grade 10 and 12)
- 2. Learner must have an active involvement in various Drug Abuse Prevention Activities.
- 3. Learner must be Drug-Free, with Good Moral Character, certified by the School Guidance Counselor or School Head.
- 4. Learner must be endorsed by the School Head with supporting document/s (Accomplishment Report) of his/her in the Preventive Drug Education Campaign.
- 5. The selection of the outstanding candidate by school will be submitted to the Division Office starting February 24 until March 3, 2020. Entries will be selected during the Initial Screening by the Division Office on March 4. 2020.
