## INVITATION TO BID FOR

### RE-BIDDING FOR THE PROCUREMENT OF SUPPLEMENTARY LEARNING RESOURCES (SLRs) FOR THE SCHOOL LIBRARIES (LOT 7, LOT 9, LOT 11, AND LOT 12)

1. The *Department of Education, City Schools Division of the City of Tayabas*, through the *FY 2025 General Appropriations Act (GAA) Republic Act (RA) 12116* intends to apply the sum of *Six Hundred Eighty-Six Thousand Two Hundred Ninety Pesos and 55/100 only (P686,290.55)* being the ABC to payments under the contract for *Re-bidding for the Procurement of Supplementary Learning Resources (SLRs) for the School Libraries (Lot 7, Lot 9, Lot 11, and Lot 12)* with *Project Identification Number ITB-GOODS-2025-002* broken down as follows:

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *Department of Education, City Schools Division of the City of Tayabas*, now invites bids for the above Procurement Project. Delivery of the Goods is required within **thirty (30) calendar days from receipt of Notice to Proceed**. Bidders should have completed, within **Three (3) Years** from the date of submission and receipt of

bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **Department of Education, City Schools Division of the City of Tayabas** and inspect the Bidding Documents at the address given below during ***Mondays to Fridays 9:00 AM to 4:00 PM except Holidays.***
5. A complete set of Bidding Documents may be acquired by interested Bidders on ***October 1, 2025, to October 21, 2025***, from the given address *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.*

9. Bid opening shall be on ***October 21, 2025, 09:30 AM*** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The ***Department of Education, City Schools Division of the City of Tayabas*** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


