Invitation to Bid for

CY 2024 Last Mile Schools Program - Construction of Two (2)-Storey Four (4) Classroom School Building with Common Toilet, Rainwater Collector, School Furniture, Solar PV Energy System and Water System for Eugenio Francia Integrated School (Formerly Eugenio Francia Elementary School)

1. *Department of Education, City Schools Division of the City of Tayabas*, through the *FY 2024 General Appropriations Act (GAA) Republic Act (RA) 11975* intends to apply the sum of *Twenty-Three Million Four Hundred Thousand Pesos only (Php23,400,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *CY 2024 Last Mile Schools Program - Construction of Two (2)-Storey Four (4) Classroom School Building with Common Toilet, Rainwater Collector, School Furniture, Solar PV Energy System and Water System for Eugenio Francia Integrated School (Formerly Eugenio Francia Elementary School) with Project Identification No. ITB-INFRA 2025-001*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Department of Education, City Schools Division of the City of Tayabas*, now invites bids for the above Procurement Project. Completion of the Works is required *within two hundred sixty-nine (269) calendar days upon receipt/acceptance of the Notice to Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Department of Education, City Schools Division of the City of Tayabas* and inspect the Bidding Documents at the address given below from *8:00 AM to 4:00 PM, Monday to Friday except Holidays*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *October 7, 2025, to October 27, 2025*, from given address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (Php25,000.00) only*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.

6. The **Department of Education, City Schools Division of the City of Tayabas** will hold a Pre-Bid Conference¹ (combination of face-to-face and videoconferencing) on **October 15, 2025, 2:00 PM** at **Department of Education, City Schools Division of the City of Tayabas, Assistant Schools Division Superintendent (ASDS) Office, Brgy. Potol, Tayabas City**. Prospective bidders who opt to attend online are encouraged to send a request for a virtual link to BAC Secretariat one (1) day before the schedule of activity through the official e-mail address: **bac.tayabas@deped.gov.ph**.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **October 27, 2025, not later than 09:15 AM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on **October 27, 2025, 09:30 AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Department of Education, City Schools Division of the City of Tayabas** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
