With the release of Philippine Professional Standards for School Heads (PPSSH) and the Philippine Professional Standards for Supervisors (PPSS), the Department of Education (DepEd), through the Bureau of Human Resource and Organizational Development-Human Resource Development Division (BHROD-HRDD) and the National Educators Academy of the Philippines (NEAP) in collaboration with the Philippine National Research Center for Teacher Quality (RCTQ), will conduct a Series of Online Orientation on the Philippine Professional Standards for School Heads (PPSSH) and the Philippine Professional Standards for Supervisors (PPSS).
