Sa 'Pinas Ikaw ang Ma'am at Sir (SPIMS) is a reintegration program implemented by the Department in collaboration with the Department of Labor and Employment (DOLE), the Commission on Higher Education (CHED), the Professional Regulation Commission (PRC), and the Philippine Normal University (PNU). SPIMS aims to assist Overseas Filipino Workers (OFWs) who are eligible to teach in public schools by providing them with local teaching opportunities.

Over the years, this office has not just been receiving queries and concerns from the SPIMS beneficiaries regarding the implementation of the said program but also provides appropriate action to address the needs of the beneficiaries.
