PROJECT "GURONG CALABARZON SUPORTADO ANG PATULOY NA EDUKASYON"

To **Schools Division Superintendents**

1. The Department of Education has developed a Basic Education – Learning Continuity Plan (BE-LCP), a package of education interventions that respond to basic education challenges brought about by COVID-19 (DepEd Order No. 12, s. 2020).

The DepEd IV-A CALABARZON is ensuring that the BE-LCP in the region is appropriate, taking into consideration the different context and situation of each of the 21 schools division that can help address limitations, challenges, and possibilities in the implementation of LCP in the field.

2. Teachers and non-teaching personnel have played a key role in the implementation of the LCP, displaying their support to the Department's call to continue the delivery of basic education in the face of a pandemic with their participation in the different activities related to LCP and their initiatives to adapt and implement different directives and strategies in their school and office.

 - d. **Sharing of content in official FB pages.** Official DepEd Tayo pages (including the regional FB page, DepEd R-4A Calabarzon) in the regional office, division offices, and schools are encouraged to share on their FB pages the photos, videos, and stories posted by teachers, non-teaching personnel, learners, and other stakeholders who used the project's official hashtags.
